| 5. Project Description: | A ditch clearing and roadway drainage improvement project will occur along State Road 62, State Road 66, and US 41 roadways near and within Evansville. This project will impact 207 linear feet of UNT to McFadden Creek due to channel excavation and clearing. Compensatory mitigation will be provided through the purchase of 207 linear feet of stream credits from the Ohio-Wabash Lowlands service area of the INDNR Stream and Wetland Mitigation Program (INSWMP).
