

By this letter, I am administratively amending the FY 2010-2014 TIP per request of INDOT's Central Office. This amendment programs two environmental mitigation projects related to the SR 25 project, des numbers 0901664 and 0901665 into Table 3, Funded Indiana Department of Transportation Projects. The estimated construction cost for the first project is \$2,500,000 (\$2,000,000 federal share) and \$250,000 (\$200,000 federal share) for the second project.

The request meets our administrative amendment criteria: 1) this project is an INDOT project using dedicated Federal Funds (NHS funds), and 2) the established TIP approval process will delay the letting date.
