

**WHEREAS,** the FY 2022-2025 DMTIP needed to be modified for project DES #2003023 to move RW from FY24 to FY25; and





**WHEREAS,** the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

**WHEREAS,** the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

**WHEREAS,** the FY 2022-2025 DMTIP needed to be modified for Project DES #1900774, Kitselman Trail Phase 3, to add FY24 CN \$300,000 to FY25 CN and increase CN by \$130,275 local match; and

**WHEREAS,** the FY 2022-2025 DMTIP needed to be modified for Project DES #1900774, Kitselman Trail Phase 3, to increase FY25 CE by \$30,000 Federal and \$12,615.80 local match; and

**WHEREAS,** the above modifications to DES #1900774 were reviewed and approved by the TPC by email vote concluding on February 21, 2024.


**NOW, THEREFORE, BE IT RESOLVED** by the Transportation Policy Committee of the DMMPC as follows:

**Section 1.** That the FY 2022-2025 DMTIP be modified for Project DES #1900774 to add FY24 CN to FY25 CN and increase CN by \$130,275 local funds for total CN amounts to be \$3,074,580 Federal funds and \$898,420 local match for a total CN amount of \$3,971,000 as shown on the attached Exhibit A.

**Section 2.** That the FY 2022-2025 DMTIP be modified for Project DES #1900774 to increase FY25 CE by \$30,000 Federal and \$12,615.80 local funds for total CE amounts to be \$376,800 Federal funds and \$99,315.80 local match total CE amount of \$476,115.80 as shown on the attached Exhibit A.



**Section 1.** That the FY 2022-2025 DMTIP is amended for City of Muncie Project DES #2003046 by adjusting previous FY22 PE amounts from \$166,400 STP 3 funds and \$41,600 Local funds to \$174,298 STP 3 funds and \$43,575 Local funds, adding FY25 CN in the amounts of \$784,000 STP 3 funds and \$1,132,257 Local funds, adding FY25 CE in the amounts of \$117,600 STP 3 funds and \$29,400 Local funds, and adding FY25 PE Utilities in the amounts of \$7,200 STP 3 funds and \$1,800 Local funds as shown in Resolution 24-22 Exhibit A.
