Curt Ayres, CEO, Miriam Cho, Pharm D, and Jody Bogt from CAPSA were present for the variance request.

MAC Rx is requesting a variance to permit them to operate the FirstDose system as an electronic emergency kit in its current and future long-term care facilities in the state of Indiana. It is a web-based software platform that permits MAC Rx to control access to this emergency drug supply by assigning unique access codes and defining access levels for facility and pharmacy staff. It tracks every entry into the system and every patient transaction at the pharmacy 24/7. The system constantly monitors inventory levels to permit prompt replenishment, identifying expiration dates and lot numbers for auditing and allows minimal inventory levels in the system.

The use of the FirstDose Electronic Emergency Kit in Indiana facilities would improve care to the facility residents and increase compliance than the use of a tackle box system. This system would provide: Better security; better accountability; better availability; monitors drug effectiveness-monitors expiration of all drugs in the system.

The Board thanked Mr. Ayres for his presentation. They will be scheduled again in March as they must appear twice for a variance request.

# <u>Tracy Perry, PharmD., R.Ph. Vanderburg County Health Department – INSPECT request:</u>

Kara gave the Board some background regarding this matter. She informed the Board that in an email she received from Mr. Perry he indicated that he had looked up 2017 and 2018 deaths in INSPECT to run a data analysis. He did not have permission and did not have a relationship with the patients he reviewed in INSPECT.

Mr. Perry admitted to the Board that he did do this as he felt it was in the realm of a

pharmacist duties and then he reviewed the law and put a halt to his process as he realized he should not be looking them up without the Board's permission. He looked up seventy-four (74) patients from 2017 and thirty-one (31) patients from 2018.

He is now requesting information from INSPECT on deaths from 2013 to 2017.

The Board informed Mr. Perry that he will need an IRB before they can consider granting the request.

### Medicine Plus, License # 60005748A – Remodel Application:

Mr. Schuckman indicated that he is doing a remodel and has been pro-active regarding the issues in the inspection report. He stated that he is getting policies and procedures in place regarding the issues so they will be compliant. He also stated they are doing training on the policies and procedures so staff will know what they are to do. He has a task list that comes up daily, weekly and monthly on the computer so staff will know what needs to be done. He then verifies that the task list has been completed. Each task has the location of instruction in the policies and procedures manual so if someone doesn't understand they can easily look up the instructions. He has certain staff assigned to take inventory and to take the expired drugs off the shelfs.

Michael Vicoso, R.Ph, PIC has been the pharmacist in charge at Keystone Choice Pharmacy since April 2016.

He indicated that they have less than ten (10) patients in Indiana when the license was active. He is at the Pennsylvania pharmacy.

He stated he was present when OIG came in with a search warrant. He states as far as he could tell they took copies of hard drives and collected documents. He didn't know what exactly was taken as he was not allowed to stay inside the pharmacy area, but indicated he was right outside it for the nine (9) hours it took to complete the warrant search.

The do not do any kind of compounding.

They employ 57 pharmacy technicians as well as at least five (5) pharmacists. They indicated that sever of the technicians manned the telephones to take orders for products.
