Discussed – Daily activity logs were still in Respondent's "mailbox/bin" for weekend work for the weekend in question. Two residents informed investigators that neither received services from Respondent. The Respondent submitted billing for that day in question. There was no way for him to provide 4 hours of service and get to the location he indicated he was at and enter the billing. He was terminated for billing for 4 hours of service when he didn't show up to the facility – falsification of billing and falsification of his timecard.

State's closing – Respondent hasn't shown up for either hearing, hasn't responded to the OAG. The State has proven he didn't provide services he billed for and time he submitted he worked. He told different stories to different people. He failed to disclose that he was terminated on his renewal application. Thorough investigation, two employee statements, two resident statements, and activity logs were still in the same place and blank. The State has met the burden of proof and his license should be disciplined.
