FULL BOARD APPEARANCES

Candace Backer, Physician Assistance Coordinator, Indiana State Medical Association, appeared before the Board to give an overview of the Indiana State Medical Association's Physician Assistance Program (ISMA PAP).

Ms. Backer stated that ISMA PAP has 13 district representatives around the state that meet quarterly. Sixty percent of the physicians that ISMA PAP sees are there due to substance abuse. The other forty percent are seen for other issues.

Ms. Backer explained the process ISMA PAP has for working with a physician. This process involves sending them for a comprehensive assessment at one of their approved programs throughout Indiana and neighboring states. An assessment includes, but not limited to, psychiatric evaluations, medical history and physical and collateral data. She mentioned that Positive Sobriety, Inc. in Chicago, Illinois is the closest program to Indiana that they utilize for comprehensive physician assessments who are being monitored for substance abuse. A contract is signed between ISMA PAP and the physician. The contract length is determined by ISMA PAP.

Ms. Backer stated that they have seen a rise in distressed physicians related to certain types of psychosis issues including, but not limited to, burnout or suicide issues and ISMA PAP closely works with psychiatrists to monitor this. Physicians who are being monitored for these types of issues typically have a work-side monitor or mentor to help with the program.

Ms. Backer also stated that ISMA PAP works with physicians who have been disciplined for having patient relations that are personal in nature, violating ethical boundaries. They have treatment programs that are specifically tailored to these types of physicians. Comprehensive teams of people are put together for these physician by ISMA PAP.

Ms. Backer also stated that ISMA PAP will also handle comprehensive assessments for physicians with alleged dementia issues.

Ms. Backer concluded with issues that may arise with a physician who is non-compliant with their ISMA PAP contract. If the physician fails to meet the terms of the contract, ISMA PAP will write a comprehensive letter summarizing why the Physician is non-compliant and submit it to the Board Director. The Board Director will then file a complaint with the Attorney General's office.

Respondent failed to complete ninety-two (92) patient charts from September 23, 2015, until January 2016.
