Meredith Lizza, Director of Communications and Legislative Affairs for the Indiana Professional Licensing Agency, appeared before the Board to update them on current 2018 legislation.

Meredith presented information to the Board on the following legislation:

SB221 - INSPECT Program - allows a dispenser of ephedrine, pseudoephedrine, or a controlled substance to transmit certain information to the INSPECT program by any electronic method that meets specifications prescribed by the state board of pharmacy (board). This impacts all Indiana Controlled Substance Registrations and will be effective on July 1, 2018 with rolling effective dates for mandatory query of a patient's INSPECT record. The roll out will start January 1, 2019.

SB223 – Information Provided by Health Practitioners - requires specified licensed health practitioners to provide certain information related to the practitioner's work, including the practitioner's work with Medicaid patients, when renewing the practitioner's professional license online. This impacts licensed physicians and will be effective July 1, 2018.

SB225 – Continuing Education Requirements - establishes continuing education requirements for licensed health care practitioners who apply for a controlled substances registration. Provides that the continuing education requirements expire July 1, 2025. This impacts all Indiana Controlled Substance Registrations and will be effective July 1, 2018 and expire July 1, 2025.

SB340 – Regulation of Abortion and Newborn Safety Devices - which makes various changes to the abortion law concerning abortion clinic license applications, abortion clinic inspections, abortion inducing drugs, abortion complications, the provision of information to a woman seeking an abortion, and the collection of data by the state department of health. Specifies under the safe haven law that it is a defense to a claim of neglect of a dependent if the individual left the child in a newborn safety device that is located at a fire department, including a volunteer fire department, that meets specified requirements. This impacts licensed physicians and will be effective July 1, 2018 with some rulemaking language for the Indiana State Department of Health effective upon passage.

HB1119 – Physician Order for Scope of Treatment and Consent – impacts licensed physicians and physician assistants and will be effective July 1, 2018.

HB1191 – Suspected Human Trafficking - removes the requirement that a licensed health practitioner report that an adult patient is a suspected victim of human trafficking to a local law enforcement agency. Requires a licensed health practitioner to provide information concerning available resources and services to a patient who is a suspected victim of human trafficking. Impacts the Medical Licensing Board and will be effective July 1, 2018.

HB1130 - Professional Licensing Agency Matters - provides that certain duties of the medical licensing board are now duties of the committee of hearing aid dealer examiners; Removes provisions that: (1) permit a student in medical school to take the medical licensure examination; and (2) concern grading examinations and how often the exam is administered. Changes a reference to a postgraduate training program that allows a permit to be issued to a foreign medical graduate. Requires a physician to make a personal appearance before the medical licensing board to establish the physician's work history if the physician has been inactive for more than three years. (Current law requires an appearance if the inactivity period is more than four years.) Impacts the Medical Licensing Board and will be effective July 1, 2018 with emergency rulemaking provisions for third party logistics providers.

HB1245 – Occupational Licensing - specifies the notice requirements for network health care providers that make referrals via telephone to out-of-network health care providers. Impacts Medical Licensing Board and became effective March 21, 2018.

John P. McGoff, M.D., President, Indiana State Medical Association and Michael Brady, Director of Advocacy, Indiana State Medical Association (ISMA)

Dr. McGoff presented a few highlights to the Board regarding additions to current ISMA programs. Dr. McGoff stated that ISMA recently received a grant from the Fairbanks Institution regarding physicians and opioid prescribing and how to help them navigate serving their patients who require opioid pain management.

Volunteers in Medicine of Dearborn, Ohio, and Switzerland Counties (VIMDOS), Lawrenceburg – Volunteer Registry Location

VIMDOS Clinic will offer health care services to underserved and uninsured patients from Dearborn, Ohio, and Switzerland counties in Indiana.

The services provided may include general primary care; treatment & monitoring of common illnesses and health problems; health education about nutrition, aging, safety, diabetes, hypertension, etc.; medication education and assistance; health assessment and screening; health care coordination and navigation with a goal to connect to community resources.

Services will not be provided for chronic pain management, obstetrical care, or primary treatment of mental health concerns. Prescriptions will not be provided for controlled substances.

The Board discussed that to be on the Indiana Volunteer Location Registry the facility type may not be any facility at which the primary purpose is to provide health care services, and since the VIMDOS Clinic's primary function is healthcare it did not meet the criteria to be added to the Indiana Volunteer Location Registry.
