Ms. Slusser informed the Board about the April 27th announcement from HHS regarding new X-waiver regulations.

The information below is from the U.S. Department of Health and Human Services, details the recent changes to the X-waiver process. In addition, there is also a free webinar, hosted by Get Waivered and California Bridge, that will help providers with completion of the Notice of Intent process, as well as answer any questions about the waiver process and administering buprenorphine.

Some of the information is as follows:

"The Guidance on New X-Waiver Requirements:

 ON APRIL 27, 2021, THE US DEPARTMENT OF HEALTH ANDHUMAN SERVICES ISSUED NEW PRACTICE GUIDELINES REGARDING THE WAIVER PROCESS FOR MEDICAL PROVIDERS WISHING TO PRESCRIBE BUPENORPHINE TO PATIENTS WITH OPIOID USE DISORDER.

NEW CHANGES TO GUIDELINES

- UP TO 30 PATIENTS CAN BE TREATED WITHOUT COMPLETING X-WAIVER TRAINING
- UP TO 100 PATIENTS CAN BE TREATED ONCE THE CONTROLLED SUBSTANCE ACT (X-WAIVER)
 TRAINING IS COMPLETED.
- REFERRING TO OR PROVIDING PSYCHOSOCIAL SERVICES IS NOT REQUIRED. PROVIDERS SHOULD STILL FOLLOW BEST PRACTICE CARE MODELS WHEN DECIDING REFERRALS TO PSYCHOSOCIAL SUPPORTSERVICES

EVEN IF YOU DO NOT COMPLETE THE TRAINING, YOU MUST COMPLETE A NOTICE OF INTENT (NOI) WITH SAMSHA TO PRESCRIBE BUPRENORPHINE

These changes apply to physicians, Advanced Practice Registered Nurses (APRNs), Physician Assistants, and other providers eligible to prescribe medications

The impact of these changes for emergency medicine providers is still being sought. At this time, emergency medicine providers can still follow the "three-day rule" of administering buprenorphine to patients in the ED. <u>Pfeiffer Prescription Services – Non Resident Change of Ownership – Positive Response:</u>

Hari Kumar appeared on behalf of Pfeiffer Prescription Services.

He indicated to the Board that Kenneth Behr, R.Ph., PIC has had action taken upon his license.

On November 4, 2005, Mr. Behr entered a consent order with Illinois. The consent order was based upon sister state pharmacist license discipline.

He received a felony conviction in the State of Michigan for attempted embezzlement in 2020 and voluntarily surrendered his pharmacist license. He received a misdemeanor conviction in Indiana in 2003 for attempted theft and voluntarily surrendered his pharmacist's license. His Indiana license shows revoked in 2003. His Texas license was revoked due to non-appearance for his board hearing.

The Illinois consent order was for a thirty (30) day suspension followed by indefinite probation for three (3) years. His probation was lifted in 2009.

- Stephen Blanford, R.Ph. in 2003 was disciplined by the Kentucky Board following an inspection and inventory of controlled substances showed missing medication.
 Mr. Blanford was the PIC at Medical Towers Pharmacy when this happened.
- Joe Eiler, R.Ph. in 2016, during a non-sterile compounding inspection at Commons Community Pharmacy where Mr. Eiler was PIC, it was found that legend drugs and prepared prescriptions medications were in a newly constructed section of the pharmacy that had not been inspected or approved by the Board.
- Matthew Weaver, R.Ph. in 2016, Mr. Weaver called in a fraudulent prescription for himself to a Walgreens.

DISCUSSION

<u>Discussion – does the law permit a prescription to be filled in one location and dispensed in another:</u>

Kurt Miller, J.D, Board's Advisory Counsel from the Attorney General's Office explained to the Board, that after reviewing relevant statutory authority and administrative rules, his answer is as follows: Not including controlled substances, generally speaking prescriptions may not be filled at one location and dispensed in another location, unless the pharmacy meets the requirements of the remote dispensing statute IC 25-26-13.5 and the emergency remote dispensing rule, LAS #18-325(E).

Mariam Habib, R.Ph., request for an extension of time to take the NAPLEX exam: Ms. Habib submitted a written request to the Board asking for a six (6) month extension of time in which to take the NAPLEX examination. She stated she needs more time for studying.
