## **Draft report to General Assembly – SEA 189 (2019)**

Pursuant to SEA 189 (2019), the Board took comments received regarding application process and requirements under advisement.

Tammy Hurm, ICASE requested to be allowed to make comments regarding SEA 189.

Ms. Hurm stated that she feels the Emergency Permits are the best solution. They should look at the requirements in schools. They need to have IEP (individualized educational plans).

The Board reviewed the draft report for submission to the General Assembly pursuant to SEA 189 (2019) and made the following suggestions to be added to the report:

- Interstate compact for Speech Pathologists Utah, Montana and Wyoming are all currently interested in joining a compact before the compact can be realized there must be at least ten (10) states prepared to join.
- Telehealth and telesupervision
- Caseload limits
- Support Personnel should be changed from having three (3) tiers down to just Assistants. They would need to redefine education and supervision. ASHA is moving toward certifying Assistants. Audiologists also have Assistants so each would need to be specific to the profession.
- Use of alternative case load model Ohio has a good one.

Ms. Turner thanked all involved with this discussion and made is clear that the report is from the Professional Licensing Agency.
