### ADMINISTRATIVE HEARINGS

<u>John Chapman, P.A., License No. 10000654A, Cause Number 2013 PAC 0003</u> Respondent appear telephonically and was not represented by counsel regarding a Petition for Reinstatement scheduled before the Board. The State of Indiana was represented by Ryan Eldridge, Deputy Attorney General and the court reporter sworn in for this matter was Lindy Meyer with Accurate Reporting Services also appeared telephonically.

Mr. Chapman applied for reinstatement with the Board back in 2018 ad was denied as his order indicates he cannot reinstate until his Texas license is unencumbered.

Mr. Chapman testified that he contacted the Texas Board and they gave him a letter that indicates his is not eligible for reinstatement. He submitted the letter for the Board's review.

The Board indicated that the letter does say he is not eligible for reinstatement due to being away from the profession for such a length of time, but it also indicates it is due to the discipline as well as other reasons.

He informed the Board that he has completed anger management classes; saw a Psychiatrist for a period of time and was released. He stated he has been clean and sober since 2012.
