# Meredith Lizza, Legislative & Communications Director, PLA:

Ms. Lizza appeared to discuss with the Board HEA 1245 which requires all Boards to do emergency rules that are due November 2018. This will be to determine what if any criminal actions that may exclude a person from licensure.

The designated representative from all Boards will attend a meeting to discuss in length the criminal actions that may be on the list. This listing is to provide the public that may want to apply for a specific license the ability to review to see if they could be excluded from licensure before the attend school or training for that license.

### **Emergency Disorder Permits:**

Mr. Covington informed the Board that these permits are issued by the Department of Education, but the statute has expired. Those with this permit should not be practicing.

### 2015 & 2017 Continuing Education Audit

Ms. Edens gave a report on the 2015 and 2017 completed CE audits. The 2014-2015 audit there were four (4) audiologists audited with one (1) of those non-compliant and subsequently suspended. There were thirty-two (32) speech language pathologists audited with three (3) non-compliant and two (2) suspended.

The 2016-2017 audit there were four (4) audiologists audited with all compliant and thirty-one (31) speech language pathologist audited with three (3) non-compliant and two (2) suspended.
