# INSPECT discussion with Kara Slusser, Zaneta Nunnally & Bret Busby:

Participating Members: Matt Balla, Mark Smosna, Winnie Landis, Donna Wall

Bret spoke about a recent pharmacy inspection at a large chain pharmacy. While reviewing files for a specific complaint that was sent to our office, he noticed that the dispensation date submitted to INSPECT for several controlled substance prescriptions did not match the point of sale date listed at the pharmacy. He made sure to report this discrepancy to the Director of INSPECT and the Compliance Director. Upon further investigation, it was discovered that many pharmacies are reporting their dispensations to INSPECT on the filled date, not the date that matches the point of sale.

Zaneta explained that she had seen similar reporting issues from other facilities. Approximately one month earlier, she had been contacted by a practitioner who noticed incorrect dispensation dates for his patient and inquired about how this mistake had been made. The Compliance Director requested files from the dispensing facility, which were matched up with PMP Clearinghouse data submissions, provided by the INSPECT Director. They discovered that this facility was submitting controlled substance data on the date that they billed patients for their medications, not on the date that the medications were dispensed to the patients.

Kara informed the Board that this was a violation of IC 25-26-24-17, which states, "The information required to be transmitted under this section must be transmitted not more than twenty-four (24) hours after the date on which ephedrine, pseudoephedrine, or a controlled substance is dispensed." Furthermore, submitting dispensation data to the PDMP before the point of sale creates several additional problems. For example, state statute requires dispensers to submit information on the type of payment used to purchase the medication and the identification number of the individual picking it up. If the dispensation data is submitted to the PDMP prior to the point of sale, there is no way for the dispenser to accurately relay this information to the state. Kara propose a meeting with our PDMP technology vendor to discuss this issue and how it can be resolved. INSPECT also need to send notices to pharmacies about the state requirements and provide education around this subject. We will provide updates to the Board as INSPECT work towards a solution.

## <u>Accredo (Express Scripts) – Variance Request of 856 IAC 1-35-1</u>

Richard Palombo, R.Ph., and Tera Teachout both appeared on behalf of this matter.

Accredo (Express Scripts) currently has a variance of 856 IAC 1-36-7 that ends in July 6, 2020 that allows technicians to work from home.

They are requesting a new variance of 846 IAC 1-35-1 for remote pharmacy technician supervision. The pharmacist is responsible for the work performed by the pharmacy technician under the pharmacist supervision, either through direct supervision or through a secured technologic means approved by the Board.

They have had a very successful three (3) years of technicians working from home. They have not had any concerns with technicians working from home. They have less distractions and lower absenteeism.

They currently have 130 Pharmacists and 150 Technicians working from home.

After reviewing the previous variance and the new variance request, the Board determined there was enough of a quantitate difference to qualify for a new variance. The Board voted by roll call to APPROVE the new variance.
