FULL BOARD APPEARANCE

Hannah Maxey, Bowen Center - 2017 Indiana Physician Licensure Survey

Ms. Maxey provided an overview and brief history to the Board of the Bowen Center for Health Workforce Research and Policy (Bowen Center) and the 2017 Data Report of the Indiana Physician Licensure Survey.

Ms. Maxey stated that the Bowen Center handles data coordination and policy coordination regarding licensed health professions for the State of Indiana. The 2017 Indiana Physician Licensure Survey provides descriptive data on the 2017 Indiana Physician workforce.

Ms. Maxey stated that much of the data presented in the 2017 Physician Licensure Survey Data Report can inform policies and initiatives aimed at improving access to health care for Indiana residents. The Bowen Center aims to provide its stakeholders with timely and accessible information on Indiana's health workforce.

Ms. Maxey also presented information regarding the Bowen portal, which is a web based interface that allows stakeholders to access the data gathered by the Bowen Center.

Ms. Maxey shared the findings of the 2017 Indiana Physician Licensure Survey and stated that although the 2017 Indiana Physician Workforce Survey Sample has increased in comparison to the 2015 sample (11,085 versus 10,057), many similarities remain. Overall, the average age of the workforce has remained consistent, and the distribution race and ethnicity has changed very little. There were a greater number of female physicians in 2017, though they still account for around 30% of the total workforce. Distribution of specialties has also seen very little change, with primary care physicians accounting for close to 37% of the total Indiana physician workforce and psychiatrists accounting for just under 4%. Regarding workforce capacity, the psychiatrist workforce still lacks capacity in many-primarily rural- counties throughout the state which could indicate limited access to psychiatric care for many Hoosier residents.

Ms. Maxey showed that demographically, the majority of Indiana's physician workforce is male, white and non-Hispanic. The data demonstrates that demographic shifts are

occurring among Indiana Physicians as a larger percentage of female physicians are in younger age groups as compared to male physicians. Data on the practice characteristics, specialty and geographic distribution, of Indiana physicians suggest trends similar to those observed nationally. The majority of Indiana's physician workforce is concentrated in populous, urban areas, and over 60% of physicians report a specialty other than primary care (Family Medicine/General Practice, General Internal Medicine, General Pediatrics and Obstetrics and Gynecology) or psychiatric (Adult/Child Psychiatry) specialty.

Ms. Maxey concluded by stating that in addition to providing information on the overall physician workforce, the report also contains sub-sections specifically dedicated to primary care physicians and psychiatrists. The 2017 Indiana Physician Licensure Survey Data Report is a snapshot of Indiana physician workforce and offers key information that can be used to determine the best practices for improving health care for Indiana residents.

Dr. Pietras appeared before the Board with counsel, Mary Watts.

Dr. Pietras was referred by his training program to the Florida Professionals Resource Network (PRN) on December 1, 2015 due to a verbal outburst that occurred at his home while on a pager call on November 30, 2015 at approximately 5:00 p.m. and was reported anonymously to the Gainesville police by someone who overheard his outburst.

After an evaluation by an independent physician, it was determined that the impairment occurred in part due to the adverse effect of an inappropriate treatment with prescribed long-acting psychostimulants that he had taken the morning of November 30 in anticipation of the afternoon call shift. As a result he was placed on leave from his program between December 1, 2015 and February 7, 2016.

Dr. Pietras returned to his program on February 8, 2016 due to compliance with monitoring, including abstinence from psychostimulants since January 6, 2016, mandated psychiatric treatment every 1-3 months and weekly counseling.

Dr. Pietras reported this information to the Florida medical Board prior to approval of his active license, which was issued May 26, 2016.

At the June Board meeting, the Board requested that Dr. Pietras meet with the Indiana State Medical Association (ISMA) for an evaluation and possible monitoring contract, and to return before the Board after he met with ISMA.

Dr. Pietras voluntarily signed a contract with ISMA.

Dr. Murphy failed to meet the standard of care due to not maintaining adequate medical records while working at Auburn Memorial Hospital in 2011 and his New York medical license was subsequently revoked. Due to New York's revocation, Dr. Murphy's licenses in California and Missouri were also revoked. Dr. Murphy surrendered his license in Texas in lieu of additional discipline and he was banned from Medicaid/Medicare in the state of California.

Dr. Murphy completed a Physician Assessment and Clinical Education Program (PACE) in May of 2016 and is Board certified in Emergency Medicine.
