8. Have you ever had a malpractice judgment against you or settled any malpractice action?

Dr. Jain has had nine malpractice suits filed against him from February 2003 through April 2015. Of these cases two were settled for high amounts, four were dismissed, one was closed, and two are still open.

In February 2003, Dr. Jain settled a malpractice suit for one million (\$1,000,000.00) dollars for incorrectly performing a transforaminal epidural steroid injection causing the patient major permanent injury. The patient suffered a left upper extremity neurological deficit.

In April of 2009, Dr. Jain settled a malpractice suit for one million, two hundred thousand (\$1,200,000.00) for incorrectly performing a right cervical medial branch neurotomy causing the patient vocal chord paralysis, difficulty swallowing, eyelid drooping and visual disturbance.

In 2015 Respondent was employed as an M.D. at Sycamore Springs, located in Lafayette, Indiana.

In March of 2016, Respondent experienced mood disturbances and paranoid thoughts, and contacted ISMA. Respondent claimed that she did not have experience these thoughts when working as a physician.

On August 8, 2016, respondent resigned her employment with Sycamore Springs and on August 10, 2016, Respondent informed ISMA that she was moving back to New York.

On or about August 18, 2016, Candace Backer, LCSW, LCAC Coordinator of ISMA Physician Assistance Program (Backer) arranged for a mutually agreed upon inpatient psychiatric treatment for Respondent beginning August 29, 2016.

On August 22, 2016, Dr. Syed Khan and Dr. Timothy Kelly notified the Board that Respondent had been exhibiting behaviors that suggested she suffered from an untreated mental health condition that may impair her ability to practice.

On August 25, 2016, Respondent spoke with Backer.

From August 26, 2016 through October 9, 2016, Respondent did not return Backer's calls or messages and had no further contact with ISMA.

On August 29, 2016 Respondent was charged with Reckless Driving; Driving at an Unreasonable High or Low Speed so as to Endanger Safety, Class C Misdemeanor, and Resisting Law Enforcement, Defendant Uses a Vehicle to Commit the Offense, Level 6 Felony in Parke County Circuit Court.

On October 5, 2016 Respondent was discharged from the Hamilton Center in stable condition to her parents for follow-up treatment in Buffalo, New York. Respondent signed a five year contract at the time of return to New York with the Medical Society of the State of New York. Respondent's New York license is active until June 30, 2018.

On November 4, 2016, Respondent's treating psychiatrist stated that Respondent has excellent insight into her disease, had been stable since her October discharge, and was compliant with her care which was comprised of a psychiatric evaluation and treatment, therapy, and a long acting injectable medication.


