MINUTES BEHAVIORAL HEALTH AND HUMAN SERVICES LICENSING BOARD September 24, 2012

I. CALL TO ORDER AND ESTABLISH QUORUM

II. ADOPTION OF AGENDA

A motion was made and seconded to adopt the agenda, as amended.

IV. PERSONAL APPEARANCES

A. Linda S. Douglas, LCSW Applicant Re: Positive Response on Initial Application

Ms. Douglas was asked to appear before the Board to discuss concerns regarding her initial application for licensure as a clinical social worker in the state of Indiana. Ms. Douglas answered "no" to guestion 1 which asks:

Has disciplinary action ever been taken regarding any health license, certificate, registration or permit that you hold or have held?

This answer was provided despite the fact that Ms. Douglas had previously entered into a disciplinary consent agreement with the Ohio Counselor, Social Worker, Marriage and Family Therapist Board.

Ms. Douglas failed to appear for her personal appearance.

A motion was made and seconded to deny Ms. Douglas's application for licensure as a Licensed Clinical Social Worker

B. Robert K. Foley, LCAC Applicant Re: Positive Response on Initial Application

Dr. Foley was asked to appear before the Board to discuss concerns regarding his positive response on his initial application for licensure as a clinical addiction counselor. Mr. Foley answered "yes" to question 3 and question 4B

Are you now being, or have you ever been treated for drug or alcohol abuse?

Have you ever been convicted of, pled guilty or nolo contendre to any offense, misdemeanor?

Mr. Brenner raised a concern that Dr. Foley does not have the necessary certification to qualify for licensure by grandparenting. Dr. Foley indicated that he is a medical doctor with 30 years of training and experience and has met all the requirements for licensure. The Board indicated that without the appropriate certification, Dr. Foley likely will be unable to satisfy the Board, but if he wanted to provide information from whatever agency has certified him as being competent to provide addiction counseling, it would be considered.

Dr. Foley indicated that he had a DUI in 2007 in which he was stopped by a police officer driving home from a bar and he was intoxicated. He also had an altercation with his exgirlfriend in which he broke in to her house by breaking a window in order to apologize to her for his conduct. This led to a restraining order and criminal charges for breaching the restraining order which were eventually dropped. Dr. Foley was charged for refusal to submit to a breathalyzer in 2008. He was required to go through a counseling program and submit to three breathalyzer attempts a day. He completed all of his court ordered requirements stemming from these legal issues.

Dr. Foley had a witness testify on his behalf as to his credentials.

It was determined by the Board that he does not currently meet the requirements for grandparenting. If he were to meet the requirements for licensure, he should be granted a licensure on probation. The Board tabled further discussion on his application at that time.

C. Daniel Michael Knaver, LCAC Applicant Re: Positive Response on Initial Application

Mr. Knaver was asked to appear before the Board to discuss concerns regarding his positive response on his initial application for licensure as a clinical addiction counselor. Mr. Foley answered "yes" to question 3 and question 4B

Are you now being, or have you ever been treated for drug or alcohol abuse?

Have you ever been convicted of, pled guilty or nolo contendre to any offense, misdemeanor?

Mr. Knaver indicated that he pled guilty to possession of marijuana and speeding in 1984. He also had three convictions for Operation a Vehicle While Intoxicated in 2005, 2008, and 2011. In 1984, he was employed as a psychiatric technician; in 2005, he was the clinical director of a child welfare agency.

The Board had concerns regarding his other licenses and whether he had disclosed his criminal issues upon his renewals. A review of his renewals disclosed that he had not disclosed these issues in 2012, 2010, or 2008. The Board decided to wait for the office of the attorney general to investigate this matter prior to making a final determination on the license.

A motion was made and seconded to table the matter at this time.

D. Sheila S. Day, LCAC Applicant Re: Positive Response on Initial Application

Ms. Day previously appeared before the Board regarding this matter on July 23, 2012. At that meeting the Board discussed her failure to disclose a criminal conviction on her application and gave her the opportunity to consider whether she wished to withdraw her application for licensure.

Ms. Day indicated that the appeal of her criminal conviction was currently pending and was based on the charges being inappropriately filed. She indicated that she is attempting to get the matter changed to more accurately reflect the truth.

Ms. Day indicated that she wished to withdraw her application and the board accepted the withdrawal of her application.

E. Kevin Tyrone Beatty, LMFT 35001670A Re: Positive Response on Renewal Application

Mr. Beatty appeared before the Board to discuss the positive response on his previous renewal application. Mr. Beatty indicated that at the time of the renewal, he had pending criminal charges that were ultimately dismissed. These previously pending charges were the reason for his initial positive response. Mr. Beatty indicated these charges were false and that there was no basis for the criminal charges.

A motion was made and seconded to grant the renewal of his license.
