Ellen Campbell, M.D. – Positive response

Dr. Campbell answered yes to the following questions on her licensure application:

1. Has disciplinary action ever been taken regarding any health license, certificate, registration or permit you hold or have held?

Dr. Campbell took a leave of absence to receive treatment for depression and subsequently signed a contract with Virginia Health Practitioners Monitoring Program (HPMP) in 2010. Part of the monitoring agreement prohibited her from prescribing or refilling prescriptions for her patients while in treatment.

Dr. Campbell was issued a reprimand and had terms and conditions placed on her Virginia license by the Commonwealth of Virginia Department of Health Professions on March 26, 2011, due to violating her monitoring agreement with the HPMP and being subsequently terminated from the program due to prescribing refills to patients while in the monitoring program and on leave of absence.

The Commonwealth of Virginia Department of Health Professions terminated the terms and conditions and restored her Virginia license without restrictions on March 7, 2012, due to Dr. Campbell's compliance.




