Comments made during the public hearing –

Andrea Swartz and Pam Harwood, both representing Ball State, stood and spoke in support of the rule changes in LSA #19-427. The changes in LSA #19-427 will result in AXP having a positive impact on new license applicants in the state. Ball State, with the adoption of LSA #19-427, is applying for the IPAL Program with NCARB, so they may offer to new architecture student the ability accrue the required 3740 hours as prescribed by AXP, cutting what is now required, in half. The students utilizing this program will be able to become licensed faster. Internships can occur in Indianapolis, with approved mentors. There are currently 7 students out of 21 working towards this path. Ball State is in favor of the rule change. Dan Weinheimer applauds Ball State for their efforts to line up with the State in creating the IPAL program to help make Indiana competitive. Hal Kovert approved Ball States efforts to become a NCARB approved program. The Board applauds Ball State and their effort with their M.Arch Program and the steps to become a NCARB approved IPAL Program just as Ball State fully supports the rule change LSA #19-427.

Help retain graduates due to the changes this rule brings, expediting the licensing process.

Jason Shelley, AIA Executive Director, stood and spoke of his support of the LSA #19-427 rule change. It will benefit Indiana in bringing more licensees to the state.
