### 3. CLARB

The Board of Directors is resubmitting the proposal to restructure the CLARB leadership. Guidance was provided by CLARB how to add amendments and the language that can be utilized with any amendments. Resolve that the proposal be amended to add – that at least a 2/3 majority of any BODs must be from the members (current regulators or recent regulators – meaning MBM's and /or MBEs.

Add another statement that more clearly describes the regions meetings: who oversees those meeting; how they are to be delegated/assigned to oversee the region meetings; what the responsibilities of the overseers are; and how points of consideration/concern raised in those regional meeting are forwarded/conveyed to the entire BOD team.
