**VII. EDUCATION**

**1. ACL Medical Site Visit Report for Intent to Open ASN Program in Anderson – Laveda Standifer MSN, RN, CEO -Owner and Program Director**

Ms. Leveda Standifer appeared on behalf of the program. Education Compliance Officer Toni Herron stated that the program was seeking to open an ADN program in Anderson. The site visit regarding this request to open was conducted on Dec. 16, 2020. Discussion ensued regarding program design, course progression and makeup and other items related to the overall program. After suggestion regarding revision of certain policies and clarification of course credits and value, the Board voted to deny the request by ACL Medical Training (ACL) to open an Associate Degree in Nursing (ADN) program based on a series of factors. Concerns identified include:

- i. The handbook submitted for review is almost 2-3 years old. The handbook must be revised to reflect updated, current policies and procedures and apply strictly to the nursing program only.
- ii. A decision tree for the management of student complaints and concerns must be updated and clarified in a way that leaves no question on the part of the student regarding the process.
- iii. The admission policy regarding transcripts for those home school applicants must be updated to consider that there are any number of families who are choosing to homeschool their children, and these children would be excluded from program.
- iv. The admission policy regarding age of admission does not consider students that may have completed their education early because of special circumstances, such as dual credit programs etc.
- v. The admission requirement for a credit check is highly unusual and allows for potential inconsistencies within the admission process and could be interpreted as discriminatory.
- vi. Revise policy for background checks to clarify the process and how the results will be handled and by whom.
- vii. Recommend consideration of creation of points system to be applied to admissions process. This will avoid the perception of favoritism or discrimination based on two apparently equally qualified candidates.
- viii. The grading scale policy must be revised clearly to prospective students and ISBN about what kind of C meets the passing standard.
- ix. Policies for background checks and drug testing must be revised so that they are clear and easily understood by prospective students.
- x. The urine drug screen (UDS) policy is inconsistent with industry standards and must be revised to reflect best practice. The policy regarding admission, routine and “for cause” UDSs must clearly state time frames and consequences for failure to pass.
- xi. The policy regarding waivers for pregnancy raises concerns regarding discrimination, in that pregnancy is considered a state of wellness, and this same standard is not applied to other medical conditions.
- xii. Revise the policy regarding the use of ATI and provide the rationale behind requiring an 80% passing score and clarify “what does it mean to have 80%?”
- xiii. Revise policy regarding clinical preceptors in clinical sites to reflect compliance with ISBN rules and to include criteria for selection.
- xiv. Curriculum concerns include:

1. Credit creep – curriculum as presented exceeds ACEN recommended ADN program length by 9 credits
2. Hours and courses repopulated, consistency with hours, consistency with industry standards with how
3. Assignment of credit hours per course inconsistent with other programs in Indiana and across the nation
4. Inconsistency across courses regarding credit totals and contact hours-
  - a. e.g. – 4 credits – Fundamentals – 64 lecture & 32 lab hours; Microbiology – 32 lecture & 32 lab hours
5. Address areas of concerns regarding curriculum progression –
6. Anatomy & physiology 2 (A/P) presented after Med surg 1 and pharmacology
7. Chemistry in 3rd semester after pharmacology and microbiology
8. Courses considered pre-requisites to nursing major in other programs (e.g., psychology, sociology, computers, success) not presented until 3rd/4th semester
9. Success class listed in semester 7 and should logically be placed early in the program
  - a. NCLEX class (end/incorporated in review course), professions class – just seems to be not right.
10. Duplication of Practice Issues in 6th & 7th semester
- xv. Library resources are inadequate for student needs and requires the addition of an online database for student use, such as EBSCO Host or CINAHL. Education for students must be provided to be able to access and utilize these online resources.
- xvi. Clarification of policies regarding book and uniform purchase with specification regarding how the monies from these purchases will be used to benefit the student.
- xvii. Covid-19 and TB testing policies need to be revised to reflect CDC and IDOH best practices and industry standards.

This matter will not be placed on the ISBN agenda for review until all documents have been received once in their final format. The above items were those that were reviewed. Due to the passage of time, the applicant was advised to scrutinize all materials and the Board would continue their review. The list is not all encompassing, and the Board may require additional updates. **A motion was made and seconded to deny the request. King/Rock 8-0-0**

**2. Indiana University School of Nursing Bloomington BSN Program Site Visit Report for new construction – Mary Lynn Davis-Ajami PhD, Associate Dean, Bloomington and Robin Newhouse PhD, Dean, Indiana University School of Nursing**

Dr. Mary Lynn Davis-Ajami and Dr. Robin Newhouse appeared on behalf of the program. Ms. Herron reminded the Board that this site visit was for new construction only, so elements that would be surveyed in a regular site visit were not addressed. Construction of a new building named the Regional Academic Health Center has been built as a cooperative venture between Indiana University (IU) and IU Health Bloomington. The space was configured with inter-professional education and collaboration at the core. Academic partners from the IU School of Medicine, School of Nursing, School of Speech, Hearing and Learning and the IU School of Social Work will have classrooms and offices in the new building. IU Health practice partners will use the space for meetings and educational offerings to staff of IU Health. The three (3) story building has classrooms on the first floor that can be configured in many ways to accommodate different needs and still provide social distancing. The Nursing Learning Resource Center is the fundamentals lab for sophomore and contains a twenty-one

(21) bed space complete with all equipment found in a normal hospital room with half representing a med-surg unit and the other half representing an ICU setting. Ms. Cooper inquired about the number of students enrolled and Dr. Davis Ajami stated that they admit 80 traditional and 20 second degree accelerated students per cohort. The accelerated students go four (4) consecutive semesters and graduate in December of the year following admission. A motion was made and seconded to approve immediate occupancy. Rock/Miller 8-0-0

**3. Ancilla College ASN program 2020 NCLEX results – Lori Huffman MSN, RN – Program Director**

Lori Huffman, Dr. Michelle Dvorak and Dr. Dorothy Gomez appeared on behalf of the program. Ancilla College appeared as part of their current Plan of Correction and because of three (3) years below the passing standard for NCLEX of 80%. Board president Kim Cooper referred to the upcoming transfer of ownership effective July 1, 2021. This change would result in the teach out of the ASN program at Ancilla College and the initiation of the BSN program on the Ancilla campus as a part of the Leighton School of Nursing at Marian University. This plan is awaiting approval by the Higher Learning Commission on February 25, 2021. Ms. Huffman stated that the plan was to accept an incoming cohort in the fall of 2021 to the ASN program that had completed pre-requisites and to teach them out through the spring of 2023. Dr. Gomez stated that there have already been 30 applications submitted for this cohort, but it would depend on the number who met all the application standards. For this appearance, only the current program offered at Ancilla will be considered.

For 2021, so far three (3) December graduates have tested and passed, with 17 remaining to test. Changes made to admission criteria and program rigor appear to be showing results. Prior to the changes the comprehensive predictor scores were below 30% and now they range from 69 to 75 with an 85-99% probability of passing NCLEX. A motion was made to devise a new Plan of Correction to include:

- i. Continue monthly written reports and quarterly in person appearances to begin in May.
  1. In monthly reports include:
    - a. predictor scores and NCLEX anecdotal reports
    - b. Clinical sites in use and corresponding didactic course
    - c. Any change in clinical sites (addition or deletion) within two (2) weeks
    - d. Any change in faculty within ten (10) working days
    - e. Number of faculty- FT/PT status and didactic/clinical course they are teaching with field of expertise
  2. In person quarterly reports to include information provided to current students regarding change of ownership and teach out plan and any other changes because of impending transfer of ownership in addition to items listed above
  3. Aggravating factors:
    - a. Didactic course revision over two (2) years
    - b. Consistent sub-standard NCLEX results for four (4) of the last six (6) years
    - c. Faculty turnover
    - d. Lack of congruence between didactic courses and clinical sites paired with that course

**4. Ivy Tech Community College Anderson ASN program 2020 NCLEX results – Della Stillerman MSN, MSM, RN, Dean**

Della Stillerman, Dr. Jewel Diller, Mia Johnson, Denise Renna and Joyce Hudson appeared on behalf of the program. Board member Kim Cooper recused and left the discussion due to her employment with Ivy Tech Community College Terre Haute as Dean. ITCC Anderson has been asked to appear because of falling NCLEX results for the ASN program for the last three (3) years. Each year has been below the standard 80%, and subsequent year's results have been lower than the previous year. Ms. Stillerman stated that they have been working on an action plan to address this since June. Faculty turnover has been a contributing factor as well as faculty level of expertise. Issues with level of rigor for courses was also identified. Board member Dr. Mary Rock stated that ITCC has a strong state-wide curriculum and that Ms. Stillerman should reach out to other deans within the network for assistance to evaluate possible opportunities for change to improve results. A motion was made to devise a Plan of Correction for one year with the following requirements:

- i. Monthly written reports beginning in March 2021 that will include:
  1. Current NCLEX results – separated out for PN, transition and ASN tracks
  2. Identify any outliers and efforts made to prepare them to test
  3. Notification within 10 working days of any faculty changes and within 15 days of student attrition
  4. Efforts designed to provide growth and support for faculty
  5. List of current clinical sites in use and corresponding didactic course – identify any gaps that may exist
  6. Efforts employed to introduce greater use of ATI and NCLEX style questions earlier in the program -confer with ATI
  7. Efforts in place to become more familiar with system wide curriculum and to increase rigor of Anderson program
  8. Efforts employed to improve student engagement
- ii. Quarterly in person appearances beginning May 2021

The aggravating factors were the high number of attempts, Kaplan review did give her a probability and she still did not pass, not passing all the client need's category, and her awareness of her ability to cancel the exam.
5. **Felicia Redmond:** Redmond disclosed on her initial application that she finished a nursing program in 1998. She went to a refresher course in 2004 in Des Plaines IL where she obtained continuing education credits. She failed the NCLEX in 2008 and 2011. Redmond has been working as a technician in various hospitals. A motion was made and seconded to deny her application to test. Cooper/King 8-0-0. The aggravating factors were that she graduated about 21 years ago, already has had 2 attempts, the low statistical probability of passing, changes to the profession and testing plan since that time, and initial delays with graduation.
