VI. Indiana State Nurses Assistance Program

Program Director Tracy Traut presented the report and spoke with students about the benefits of monitoring.

VII. Education

1. Jersey College site visit petition to open ADN program – Melissa Chase MSN, RN

Melissa Chase, Greg Karzhevsky, Steven Litvack, Park Smith, Brenda Simpson, and Rachel Birri appeared on behalf of the program. Education Compliance Officer Toni Herron stated that Jersey College (JC) was headquartered in New Jersey and is seeking to open an Associate of Science in Nursing degree program in Fort Wayne, in cooperation with Lutheran Health. Ms. Herron stated that this proprietary program received authorization from the Indiana Board of Proprietary Education in December 2019. The program would be 6 semesters in length and 75 credits. The program is presented in a manner that is reminiscent of old diploma nursing programs, in that it combines much of clinical experience with didactic classroom instruction. Rather than be distinctly separate, they are more comingled than other programs the Board has seen. JC has high NCLEX results for their nursing programs currently in operation in Florida and New Jersey. Upon reviewing the student

handbook, Board President Ms. Kim Cooper had questions regarding the grading scale and student progression. Indiana statute requires a "C" for course passage and program completion in all nursing courses. Jersey College's grading scale lists plus and minus grades. Ms. Cooper asked about how the "C" for passage would be determined and was told that a solid C of 75% would be the standard. The issue of failing a course and the process for repeating the class was discussed and JC was asked to bring back to the Board a clearer definition of the policy and how it would affect student progression. After discussion of the admission process, Ms. Cooper asked JC for further clarification of the "first come, first served" policy for admissions. In reviewing the breakdown of hours for each class, Ms. Cooper asked that JC send a more thorough breakdown of hours between lab, clinical and didactic per course. Ms. Cooper made a motion to ask JC to provide these documents to the Board prior to a vote for final approval. If the documents can be received in a timely manner, JC will be placed on the May agenda of ISBN for final program approval. Board member Angela Morris seconded the motion. Motion carried 7-0-0.

2. Fortis College 2020 NCLEX Results – Christopher Bell RN, DNP, EMT-P – Dean of Nursing

Dr. Christopher Bell and Dr. Sheila Burke appeared on behalf of the program. Dr. Bell has been in this position for approximately 6 weeks and has undertaken an evaluation of the program, faculty, and students. He has identified Health Assessment and Transitions/Capstone as courses important to student success, so he is teaching those courses himself. Ms. Cooper asked if he had the support needed to teach and manage the program and he said yes. Dr. Burke visits the program weekly and is available for support as needed. Ms. Cooper asked about admission times for cohorts and Dr. Bell stated that a new cohort had begun this week and the next was scheduled to begin in July. Ms. Cooper stated that there was continued concern regarding Fortis NCLEX results and that the Board would continue to monitor them. A discussion will be held at the next monthly ISBN meeting about strategies in place to improve NCLEX results. Ms. Cooper made a motion to accept the monthly written report and Board member Dr. Mary Rock seconded. Motion carried 7-0-0.

3. Ancilla College Monthly in Person Report – Lori Huffman RN

Ms. Huffman and Sister Michele Dvorak appeared on behalf of the program. Ms. Cooper complimented the program on their successful tracking of outliers who had graduated from the program but had yet to test. Ms. Huffman stated that there was some confusion by graduates currently working as an RN, because of the temporary permit granted by the Governor for the health care emergency. They felt that if they tested and failed, that they could not continue to work on the temporary permit. Nursing Board Director Alyssa Servies stated that the permit was just that, a temporary permit, and that the Governor could cancel the permit ,and the students would have to cease working in the capacity of an RN immediately. Taking NCLEX and failing to pass would not affect the ability to continue to practice with the temporary permit. **Dr. Rock made a motion to accept the monthly report and Board member Donna Newkirk seconded. Motion carried. 7-0-0.**

Ms. Jennifer Gale and Dr. Jewel Diller appeared on behalf of the program. Ms. Cooper recused herself as Ivy Tech is her employer and left the meeting. Ms. Gale outlined changes being made in the program after an initial assessment to identify areas of concern. Board member Jennifer Miller, Board Vice President, complimented Ms. Gale on the thorough assessment and the efforts that were in progress. Ms. Gale stated that they were trying to hire a tutor to assist students more effectively, and Dr. Diller agreed to fund the cost

of that tutor. Ms. Gale stated that there appeared to be increased faculty satisfaction and that they felt more valued because of some of the changes underway. **Dr. Rock made a motion to accept the report and Board member Angela Morris seconded. Motion carried 6-0-0.**

Since Anderson has appeared in person at the last two meetings, they will provide written reports only until the July meeting when they will return in person.

X. Personal Appearances

- 1. Serah Kamau: Kamau graduated from a nursing program in 2003. She was licensed in the Caribbean until 2017. She has failed the NCLEX once in Indiana and twice in Florida. A motion was initially made and seconded to deny the application with a vote of 7-0-0. The motion was then rescinded by a vote of 7-0-0 after it was determined that PLA had allowed Kamau to test in 2020, despite graduating in 2003. A final motion was made and seconded to allow Kamau to test one time after completing a review course and receiving a predictor score of passing within 6 months of her appearance. King/Cooper 7-0-0.
- 2. Kimberly Boldt: Boldt's Indiana license expired in 2015, but she has been practicing in Michigan since 2000. A motion was made and seconded to renew her license. Miller/King 7-0-0.
- 3. Hope Muir: Muir failed to appear and will be reset for a second appearance.
- 4. Veronica Shaikh: Shaikh graduated in 2013. She has failed the NCLEX three times. A motion was made and seconded to allow Shaikh to test one time after completing a review course and receiving a predictor score of passing within 6 months of her appearance. King/Cooper 7-0-0.

- 5. Amandeep Kaur: Kaur failed the NCLEX three times. She appeared before the Board in 2020 and was told to complete a review course and receive a predictor score of passing. She did not finish a Kaplan review course, but still received an authorization to test. She tested for a fourth time and failed again. Kaur is currently enrolled in ATI. A motion was made and seconded to deny Kaur's application as she failed to follow the Board's order previously. Cooper/Morris 7-0-0.
- 6. Julia E. Gonzalez: Gonzalez let her nursing license expire in 2003. She returned to nursing in 2009 after completing a refresher course. Her license then expired again in 2011. A motion was made and seconded for Gonzalez to enroll in a refresher course with a clinical component within 5 months of her appearance. Rock/Miller 6-0-0.
- 7. Wanda Shorter: Shorter's license expired in 2016. She was convicted of healthcare fraud and three counts of aggravated identity theft. She is currently on the OIG exclusion list and therefore cannot provide services to Medicare and/or Medicaid patients. A motion was made and seconded to deny her application. Rock/King 7-0-0.
- 8. Jodi Gordon: Gordon completed nursing school and passed the NCLEX in 2004. Her license is permanently revoked in Ohio for behaviors related to drugs and alcohol. She also had a license denied in Kansas for fraud. A motion was made and seconded to deny her application. The aggravating factors were her nursing license history in Kansas and Ohio and the length of time since she has been out of school. Cooper/Rock 7-0-0.

The Board found, by three votes of 7-0-0, that the State met its burden and proved all three violations. A motion was made and seconded to place the license on indefinite probation for at least 24 months of active practice, or the length of an RMA, whichever is longer. Before petitioning for withdrawal of probation, Hall must complete an IPRP evaluation and complete a Board ordered RMA, of at least a year. Hall must complete an MMPI2 or the equivalent within 6 months of petitioning for withdrawal of probation. Hall will be fined \$500 for renewal fraud and a \$5 health records fee. Hall must complete CEUs (12 hours in medication administration, 12 in documentation, 12 hours in ethics/professionalism, and 12 in addiction in nursing). While on probation, Hall must cause her employer to submit quarterly reports and a signed board order. Hall should be in a role that requires on-site supervision for the entire length of probation. She may not be in a supervisory role for the entire length of probation. The aggravating factors identified were significant practice concerns, a lack of accountability, and the practice concerns that are not consistent with acceptable nursing practice. Rock/Miller 7-0-0

The aggravating factors identified were a lack of accountability, inconsistencies in Shelton's statements, Shelton working without a license, patient abandonment, and fraudulent records.
