IX. Education

1. FYI ONLY - formal closure of the IU Fort Wayne Purdue Teach Out Program (see attached)

The Board has received notification of the successful voluntary closure of the *Purdue Teach-Out Bachelor of Science (BSN) program* at the Indiana University Fort Wayne campus effective 12-21-2020. The remaining students from the Purdue University Teach-Out BSN program successfully completed all requirements for the program and graduated December 20, 2020.

For CY 2021, NCLEX YTD results are 89.3% (42/47) and NCLEX results for the life of the program reveal 93.7% (893/953) overall pass rate. Board president Kim Cooper remarked that it was refreshing to see a teach out that maintained that continued to meet standards to the conclusion of the program.

2. FYI ONLY – Caris College Letter of Intent to Open LPN program in Jeffersonville, Indiana.

The Board has received the Letter of Intent to Open LPN program from Caris College that is located in Jeffersonville, Indiana. Compliance Education Officer Toni Herron stated that this started the six (6) month clock and would result in an initial site visit in late April or early May. Caris College received authorization from the Indiana Board of Proprietary Education on September 1, 2021.

3. Monthly Reports from October and November:

- i. Ancilla College at Marian University

Ms. Cooper stated that the program appears to be proceeding to complete the program for the remaining 39 students. Ms. Cooper asked that the program be present for an in-person appearance for the December 16 meeting of ISBN.

- ii. Fortis College

Ms. Herron stated that there appears to be no new faculty turnover. Quarter 3 NCLEX results are 66%. In reading the faculty meeting minutes, Ms. Cooper noted that there appears to be more interaction and participation than previously noted by the minutes. Ms. Herron states that there is some concern that Options Behavioral Health has been closed to students' clinical experiences due to low staffing. She will contact Dr. Bell to see what accommodations are being made to find alternate clinical opportunities.

XII. Personal Appearances

1. Shea Borton: Borton was represented by Todd Ess. She reported two terminations. The first was from Indy Gastro. Borton had an injury after a bed rolled over her foot and a patient hit her in the head (previous trauma). Her second termination was from St. Vincent after she had disagreements with supervisors following an incident with a patient aspirating. Borton reported that she had no prior attendance issues or any other disciplinary issues. She has completed CEUs. A motion was made and seconded to renew free and clear, but it did not pass (King/Murphy 3-2-0). A second was made and seconded to renew free and clear and refer to the OAG. Miller/Morris 5-0-0.
2. Amber Richey: Richey was represented by Todd Ess. Richey reported that when she was at Crossroads Indiana in Fort Wayne, she reported a QMA that had issues passing medications and complying with attendance requirements. The DON ignored Richey. It was reported that Richey “flipped off” the QMA, so she was dismissed with a letter saying Richey was “not a right fit.” There were also reported attitude problems. She is currently employed with Ft. Wayne Pediatrics and is doing well. A motion was made and seconded to renew her license free and clear. King/Murphy 5-0-0.
3. Jordan Wagner: Wagner was represented by Todd Ess. She was drinking and drove her car into her significant other’s (unoccupied) car that had been parked. She was charged with an OWI and had a previous OWI in 2019. The most recent OWI occurred in Kentucky. Wagner is not on criminal probation, has successfully completed a substance abuse program, and is currently participating in counseling. She is employed by Deaconess, and letters of recommendation were submitted on her behalf. A motion was made and seconded for Wagner’s license to be renewed on indefinite probation for at least one year of active practice. Wagner must complete an IPRP evaluation, cause her employer to submit quarterly reports and a signed board order. While on probation, Wagner must keep the board apprised of her contact information and employment information and comply with an RMA (if recommended), and all statutes and rules regulating the practice of nursing. Wagner agreed with the terms. King/Cooper 5-0-0.
4. Jennifer Bailey: Bailey was represented by Jim Whitlatch. She was working for an IUH hospital when conflicts arose out of the handling of COVID-19 protocols. She resigned without notice but is considered eligible for a conditional re-hire. Before the resignation, she had great recommendations. A motion was made and seconded to renew Bailey’s motion free and clear. King/Murphy 5-0-0.
5. Alicia Cobbs-Jefferson: Cobbs-Jefferson was represented by Cynthia Marcus. Cobbs-Jefferson reported a criminal matter on her 2021 renewal application. She was charged with an OWI in Jasper County. She was placed on criminal probation where she was ordered to complete community service. Cobbs-Jefferson successfully completed her criminal probation on November 16, 2021. She also completed mental health treatment in July 2021. A motion was made and seconded to renew Cobbs-Jefferson’s license free and clear. Morris/Miller 5-0-0.
6. Anita Phillips: Phillips was represented by David Dirr. She entered into a consent order in Kentucky after she was supposed to register for a prescription reporting system. 9. Kay F. Brown: Brown did not appear and will be rescheduled.
10. Estella Motley: Motley disclosed a criminal issue on her application. She graduated from a nursing program in 2010 and has failed the NCLEX four times. A motion as made and seconded to deny the application. Cooper/Morris 5-0-0.
11. Tanjdra Rouse: Rouse graduated nursing school in May 2007. She has not been able to take the exam for a long time due to health issues. Rouse is currently working at a hospital in a non-nursing capacity. She reports that she cannot afford to go back to school. A motion as made and seconded to deny the application. Morris/King 5-0-0.
12. Jamia Keuthan: Keuthan graduated from Vincennes in 2011. She passed the NCLEX in May 2021. She is a recovering addict and graduated from the Lighthouse Recovery Center, where she currently works. Keuthan was charged with severe drug related offenses. She is on criminal probation with Vigo County until October 2027. She would like to return to Vincennes to complete her BSN. A motion was made and seconded to place Keuthan’s license on indefinite probation for the length of criminal probation, the length of an RMA, or at least 3 years of active nursing practice. She must complete an IPRP evaluation and be in a board ordered RMA for at least 3 years. She must complete an initial MMPI-2 or equivalent and follow the recommendations and then submit to a second test within 30 days of petitioning to be removed from probation. The aggravating factors included the severity of criminal charges, the volume of her criminal record, addiction to methamphetamine, and the timing. The mitigating factors include her sobriety, her work with Lighthouse Recovery Center, her desire to go on and get her bachelors, the fact that she passed her boards, and her transparency. King/Cooper 5-0-0.

13. Terry Burgess: Burgess reported a criminal matter on her 2021 renewal application. She was employed by Ortho Indy and was suspected of diversion. Burgess says she relapsed in September 2020. The Board found positive findings on all three charged violations from the administrative complaint. Porter will need to pay the following fines and fees: \$500 for renewal fraud, \$1,000 for the second violation in the administrative complaint, and \$1,000 for the third violation in the administrative complaint, and the \$5 health records fee to the OAG. Porter must also submit to an IPRP evaluation and comply with the terms of an RMA, if recommended. The aggravating factors included the absence of initial responsibility, her lack of transparency, and the repetition of her behavior. King/Cooper 5-0-0
