#### When do I get an Authorization-to-test (ATT)?

When you have satisfied all the requirements for examination, your eligibility will be granted by the Board and Pearson Vue will send your ATT to your registered inbox.

#### My application is completed, where is my ATT?

Please review your Application Checklist to ensure that your eligibility has been granted. If so, please contact Pearson Vue if you mislocate or haven't received your ATT email.

## How can I change my name on my application or ATT to match my ID?

Email pla2@pla.in.gov with your name, applicant number, detail of the discrepancy, and all applicable documents.

Email pla2@pla.in.gov with your information and request. Please unschedule your exam appointment if you re already set for one to speed up the process.
