#### VI. Education

1. University of Evansville site visit report Intent to Open Accelerated BSN – Jerrilee LaMar PhD, RN

Dr. Jerrilee LaMar appeared on behalf of the program. Education Compliance Officer Toni Herron explained that the University of Evansville (UE) was requesting to open an accelerated Bachelor of Science in Nursing track. Ms. Herron Stated that UE currently offers a traditional Bachelor of Science in Nursing degree program with NCLEX pass rates > 90 % for the last five (5) years except for 2021, because of Covid. Ms. Herron stated that healthcare partners approached UE to start the accelerated track. Both major acute care health partners stated the urgent need for nurses. To support the initiation of the program, Deaconess Healthcare has offered joint faculty appointments, space for labs and clinical, creation of a dedicated education unit and scholarships for graduates that agree to work for them for a period of time.

Ms. Herron complimented the program on the extensive research and preparation that has been done to prepare to offer the track. Ms. Herron reminded the Board that the UE had appeared in July 2023 to request the ability to present courses in an asynchronous manner. The Board denied the request as it was specifically prohibited in 848 IAC 1-2- 16 which requires concurrent didactic and clinical experiences. Based on that denial, Dr. LaMar worked with the registrar of UE to modify the summer terms to accommodate the clinical needs of the accelerated students. Admission criteria require previously earned Bachelor of Science degree with overall GPA of 2.5. The program is requesting two (2) cohorts annually of 30 students each.

Board member Ms. Cooper made a motion to approve initial accreditation for the accelerated Bachelor of Science track with two (2) admissions not to exceed 45 per year. She listed the following factors in making the recommendation to approve the request to open:

- 1. History of the program
- 2. Quality of the proposal to open
- 3. Quality of the student and faculty handbooks

- 4. Support of clinical partners
- 5. Clinical integration with simulation
- 6. Stable staffing no open positions
- 7. Backup plan in pace for joint appointments
- 8. Adequate financial reserves, space and faculty
- 9. Communication with ISBN

Board member Jennifer Miller seconded the motion. Motion carried 7-0-0.

2. Caris College site visit report PN program full accreditation – Kathryn Reed, MSN, RN

Kathryn Reed, Michelle Smith, and Bruce Kepley appeared on behalf of the program. Ms. Herron stated that Caris College was a PN program located in Jeffersonville that was appearing to request full accreditation. The first cohort of 5 have tested and passed PN NCLEX. Ms. Herron complimented the program for clear and consistent communication with ISBN when it appeared that their OB sites had been withdrawn. Ms. Reed was very persistent and creative in seeking replacement OB clinical sites and has renewed the affiliation agreement with the original clinical site through 2024. Ms. Herron stated that concerns about adequate faculty had been remedied since qualified faculty applied the week after the site visit and have subsequently been hired. That means five (5) full time and two (2) adjunct faculty are currently on staff. Ms. Herron stated that it was discovered in discussions with students during the site visit that they were being required to clean and stock supplies every Thursday and Friday. Ms. Herron informed the program leadership in the site visit exit interview that this was unacceptable, and the practice had to cease immediately. The program alleviated that issue by hiring a cleaning crew within 2 weeks of the site visit.

Ms. Cooper asked about admission and retention of the first cohort and Ms. Reed was able to recite all numbers and account for those that failed to progress for either personal or academic reasons. The program is requesting admissions of four (4) cohorts of twenty five each (25) four (4) times annually. After discussion, Board member Dr. Emily Sego mad a motion to award full accreditation to the PN program with four (4) cohorts a year for a total of 100 annually but no cohort to exceed thirty (30) students in size. Ms. Cooper seconded the motion and listed the following mitigating factors:

- 1. Timely resolution to problem areas identified at the site visit
- 2. Director's exceptional knowledge of students' progression in the program and current status
- 3. Transparency with the Board and Ms. Herron regarding loss of required clinical sites
- 4. Resourcefulness in identifying acceptable alternate clinical sites, if required
- 5. Re-establishment of communication with affected acute care clinical partners
- 6. Positive response to complaint raised by students and timely resolution of the issue

Gail Lindsay and Dr. Kimberly Mau appeared on behalf of the program. Ms. Herron stated that the site report form for construction / remodeling visits had been revised to eliminate redundancy and make better use of Board members' time. Ms. Herron stated that ITCC Evansville had remodeled space previously occupied by the business office. The space was remodeled to accommodate the anticipated increase in enrollment and the resulting need for expanded fundamentals lab space. Financial resources were made available by campus and college administration to compete this task. Faculty suggestions/requests were accommodated completely with

the remodel. After discussion, Dr. Sego made a motion to approve immediate occupancy and use of the remodeled space and Board member Angela Morris seconded. Motion carried. 6-0-0 Cooper recuses.

5. Fortis College monthly written report

Ms. Herron stated that the written report was included in the packet for review. Ms. Herron asked the Board to review the written report carefully, as there were several concerning items noted. Among them was a notation in the faculty meeting minutes which seemed to indicate that students were being allowed to select their own preceptors at the clinical site, which is in violation of 848 IAC 1-2-12 Faculty which lists requirements for preceptors. Ms. Herron reminded the Board that Fortis would appear in person at the January 18, 2024, meeting to discuss NCLEX results for 2023 that would be available at that time. She also stated that the standard deviation calculation from NCSBN, required by statute to assess a program's success, will not be available until February 14, 2024. Ms. Cooper made a motion to acknowledge receipt of the report and Dr. Sego seconded. Motion carried 7-0-0.
