# VII. Education

1. Leffler Academy site visit for Intent to Open ASN track – Amanda Leffler DNP, RN

Dr. Amanda Leffler and John Gould appeared on behalf of the program. Education Compliance Officer Toni Herron presented the findings of the site visit conducted in conjunction with the Request to Open an Associate Degree in Nursing track at Leffler Academy. Ms. Herron reported that support for presenting this program, in addition to the other programs (CNA, PN, EMT) had been made. She stated that, in speaking with current faculty, that they are eager to open this program. Students currently enrolled in the program stated that they felt that the faculty were vested in their success and wanted to see them succeed. Ms. Herron stated that the building configuration has been adjusted to accommodate this increased programing.

Ms. Herron stated that the program is proposing a unique admission plan and program length. As proposed, the program would accept either currently licensed LPN with clean and unencumbered licenses or applicants without prior healthcare licensure. The different admission paths would be designated as either RN program applicants or for licensed LPNs, a Transition program applicant. RN program applicants would need to take a TEAS admission test and score at the Proficient level for admission.

Both sets of applicants would have to complete required pre-requisite courses:

- 1. Anatomy and Physiology I
- 2. Anatomy and Physiology II
- 3. Microbiology
- 4. English Composition
- 5. Introduction to Psychology
- 6. Interpersonal Communication/Public Speaking
- 7. Introduction to Sociology
- 8. Quantitative Reasoning

Upon completion of the pre-reqs and admission, the program is proposed to require completion of the core nursing courses, in 4 quarters/12 months and earning 65 credits. Board member Kim Cooper stated that "according to 848 IAC 1-2- 17 Curriculum: registered nurse programs - The length of a full-time program shall be a minimum of two (2) academic years or its equivalent." She stated that, as presented, this program does not fit that definition. Dr. Leffler stated that they felt that the completion of the pre-requisites of the program would satisfy the other year's requirement. Ms. Cooper stated that since the pre-reqs are not part of the Leffler curriculum, and are not available at Leffler Academy, they cannot count towards the 2-year time frame, since students would not be considered a "Leffler student" during that time. The rule states "shall be a minimum of two academic years" which is non-negotiable. After extensive discussion, Ms. Cooper made a motion to table this Request to Open and allow Leffler Academy to investigate options that would allow the program length to meet the 2 academic year requirement. She stated this might include articulation agreements with neighboring programs that would be capable of providing the gen-ed pre-reqs, which Leffler could then accept in transfer. Board member Jason King seconded the motion. Motion carried 5-0-0. Leffler Academy may return before the Board when they have identified solutions for the program length.

2. Marian University Substantive Change Request for ABSN admission standards – Tia Bell DNP, RN-BC, CNE

Dr. Tia Bell, Dr. Christina Pepin and Dr. Denise Ferrell appeared on behalf of the program. Dr. Bell stated that Marian University is requesting approval for a substantive change to admission standards for the accelerated BSN program located at Ascension St. Vincent. Currently, applicants are required to hold a bachelor's degree in another discipline to qualify for admission. The change requested would allow students with previous college experience, but not a degree, to have an alternative pathway to a BSN degree in an accelerated format. Students must have at least 67 transferrable credits from a regionally accredited college or university. Minimum admission requirements consist of a cumulative GPA of 2.8/4.00 in the sciences and successful completion of all pre-requisite courses with a letter grade of C or above. If these requirements are not met, applicants are still encouraged to apply. They can request a Holistic Admission Review and the application will be reviewed by the Marian University admission committee using an established rubric. Ms. Cooper state that she thought this was an opportunity for ADN graduates to have another opportunity to pursue a BSN in an accelerated format. Dr. King made a motion to approve the substantive change as presented and Board member Jessica Harlan-York seconded. Motion carried 5-0-0.

 Ivy Tech Community College plan to suspend Medical assistant to ASN track for academic year 2024 – 2025 – Kimberly Mau DNP, MSN, RN Dr. Mau appeared on behalf of the program. She stated that the track was originally developed at the urging of clinical partners but that the number of qualified applicants in this group had dwindled of late. The numbers will be reevaluated for the 2025 - 2026 academic year to evaluate interest. This decision would be in effect for all 6 campuses providing this track. Dr. King made a motion to approve the change and Ms. Harlan-York seconded. Motion carried 5-0-0.

4. 3<sup>rd</sup> quarter report – Ancilla College at Marian University ASN program

Ms. Herron confirmed that there is only one student remaining in the program and that the ADN program should be taught out by the end of the Spring 2024 semester. Marian University has students in progression in the BSN program on this campus currently that will continue. Ms. Harlan-York made a motion to accept the report as written and Dr. King seconded. Motion carried 5-0-0.

5. Ivy Tech Lake County Notice of Intent to decrease admissions

Dr. Mau appeared on behalf of the program. The lake County decrease in admissions is required due to lack of faculty for the program. Ms. Harlan-York made a motion to approve the decrease and Dr. King seconded 5-0-0.
