

1965-1999





INDIANA ARTS COMMISSION GRANT PROGRAMS



ARTS IN EDUCATION (AIE)

Funded primarily through interest income from revenue generated by the Celebrate the Arts license plate, this program was developed to help support inclassroom, arts-related learning projects. These projects partner schools and teaching artists to develop activities that impact student engagement and performance, and develop long-term commitment to the arts in Indiana schools at the primary and secondary level.



INDIVIDUAL ARTIST PROGRAM (IAP)

This program is designed

to provide individual artists with grant assistance for specific projects that will help further their career development. Grants have been used to meet the artists' needs in promotion, business development, and developing and reaching new markets for their work. The program also encourages artists to develop projects that have a positive impact on their communities where they live and work.



CAPACITY BUILDING PROGRAM

Capacity Building Program grants assist established and emerging institutions and artists by building effective leadership, sound management practices, diverse financial resources, and successful partnerships. Applicants must be a private, nonprofit, tax-exempt agency, or Indiana public entity. Applicants scores are based on three key criteria: educational value; community participation and accessibility; and planning and evaluation.



MULTI-REGION ARTS OPERATING SUPPORT (AOS III)

Formerly known as Multi-regional Major Institutions, or Majors, this grant is for Indiana's largest arts organizations. Recipients must have a budgt in excess of \$1 million and a multi-regional service area with a focus on underserved communities and educational opportunities. These organizations provide significant economic and employment impact in the communities where they are located, and contribute to the economic and cultural tourism development of the entire state.



STATEWIDE ARTS SERVICE ORGANIZATIONS (SWASO)

This grant program helps strengthen the capacity of arts organizations offering training and or technical assistance services on a statewide basis. Such projects may include seminars, conferences, workshops and training sessions.



REGIONAL INITIATIVE GRANTS (RIG)

In most regions, there are three primary grant categories awarded for cultural programming providers. Grant amounts vary depending on a variety of factors.

Large Operating Support (AOS II)

This category is for organizations with annual cash incomes of \$250,000 or more.

Small Operating Support (AOS I)

This category is for organizations with annual cash incomes of \$249,999 or less.

Project Support (APS)

Arts Project Support grants are designed for cultural program providers that do not have a primary arts-focused mission. Many libraries, universities, public schools, and community centers qualify for this grant category.

OTHER STATEWIDE EFFORTS



TRADITIONAL ARTS INDIANA (TAI)

This partnership between the IAC and Indiana University's Folklore & Ethnomusicology Department documents, promotes, and presents Indiana's traditional arts and artists, particularly those practicing art forms handed down through generations reflecting ethnic, cultural, and geographically unique customs. Each year, TAI and the Indiana Arts Commission present Traditional Arts Master awards at the Indiana State Fair.



POETRY OUT LOUD

Each year, the IAC hosts the state Poetry Out Loud competition, a poetry recitation contest for high school students supported by the National Endowment for the Arts (NEA) and the Poetry Foundation. Students first compete at a local level to determine which students will represent their respective schools in the state final competition. The state champion represents Indiana at the National Finals in Washington, D.C.



INDIANA STATE POET LAUREATE

Created by legislative directive, the Indiana State Poet Laureate program brings poetry and the power of the written and spoken word to Hoosiers of all ages. The program provides a framework for the development of specific educational programming coordinated between the Indiana Arts Commission and the State Poet Laureate. It also charges the IAC with coordinating the selection process for the State Poet Laureate. The Poet Laureate serves a two-year term and is provided with a small stipend. The current Poet Laureate is George Kalamaras.



CULTURAL DISTRICT CERTIFICATION PROGRAM

A cultural district is a well-recognized, labeled, mixed-use area of a community in which a high concentration of cultural assets serve as the anchor. This legislatively enabled program, administered by the IAC, establishes criteria and a selection process to identify such districts. The program helps certified cultural districts promote the exploration of and participation in the arts and humanities through cultural experiences that are unique to their communities.



CULTURAL TRUST FUND

Created by legislation in 1997, the Indiana Cultural Trust was established as a vehicle to enhance and stabilize funding for the arts, encouraging, promoting, and expanding the arts for future generations of Hoosiers. For each purchase and renewal of the Indiana Celebrate the Arts special- issue license plate, a \$25 donation goes to the Cultural Trust Fund. Interest income from the Trust Fund investment annually supports the Indiana Arts Commission's Arts in Education program.



CAPACITY BUILDING **WORKSHOPS**

Capacity Building Workshops help connect educational opportunities to constituents. The first such workshops were held in 2010 and have continued each year since, providing professionally-led training and focused discussion on a broad range of subjects related to fundraising, building stronger communities and partnerships, and organizational leadership.



REGIONAL ARTS PARTNERSHIP

A key IAC partnership program, the Regional Arts Partnerhip is the cornerstone of the IAC's efforts to enhance service delivery and cultural decision-making at the local level. Through this partnerhip, arts providers have better access to IAC services and increased public awareness and advocacy for the arts at the community level. A significant portion of the IAC's granting budget goes to the Regional Arts Partnership. Each region receives administrative funds to provide services and a Regional Initiative Block Grant for regranting to cultural providers within their region.



GOVERNOR'S **ARTS AWARDS**

This biennial awards program, conceived in partnership with the Office of the Governor, is administered by the IAC. The purpose of the awards is to honor significant contributions to and achievements in the arts, which have had a profound positive impact on the State of Indiana. The IAC also commissions the creation of new artwork by an Indiana artist which serves as the award piece. In this way, the awards also encourage the creation of new works of art by contemporary Hoosier artists.



ARTS MIDWEST

Arts Midwest, one of six regional arts organizations in the U.S., serves audiences, arts organizations, and artists throughout Illinois, Indiana, Iowa, Michigan, Minnesota, North Dakota, Ohio, South Dakota, and Wisconsin. The IAC annually provides a grant to Arts Midwest which, coupled with other Arts Midwest support, regrants to presenters and performing touring artists from Indiana, allowing them to tour throughout the Midwest. This also provides greater opportunities for Indiana presenters to showcase the best of Indiana and Midwest artists.



ARTSWORK INDIANA

ArtsWORK Indiana is an informal, statewide group of people interested in improving artsrelated professional opportunities and careers for people with disabilities. This statewide network of artists, educators, vocational professionals. and cultural organizations provides career-related information and networking, peer-to-peer encouragement, and increased awareness of Hoosier artists with disabilities and their contributions.

The middle left photo comes to us from AOS I recipient Beachfront Dance. Beachfront dance held a popular Phantom of the Opera workshop.



Their students perform under top-rate conductors, and have weekly sectionals with professional musicians from our community, thereby supporting the arts in South Bend as well.







Petera Nyendick, Director of the ISU Community School of the Arts said, "Funding for Fusion Theater allowed Indiana State University's Community School of the Arts to offer an outreach program at Sarah Scott, the only Title 1 middle school in Terre Haute, Nyendick said. "Twenty-five students participated in after-school theater programming during the 15-week spring semester. The program culminated with three performances in May: at the school, at a professional theater, and at a community center. Indiana Arts Commission grants have real impact on the lives of kids enrolled in Community School of the Arts programming. The CSA staff and instructors bear witness to significant changes in children that participate in the arts. Kids gain self-confidence, have greater ease in social situations that require team participation, and feel pride in accomplishment."

The center and lower right photos are from their FY15 Rock Camp project held in July. One camper said, "I can honestly say that this rock camp is absolutely my favorite camp that I have ever been to. In only a week, the incredible instructors here have helped me vastly improve my keyboard and vocal abilities. 

Region 8 had a fantastic two years! The top image is from Lotus Festival. Children engaged in an arts and crafts activity at the festival.






