## LICENSES, PERMITS, AND IDS

The below section outlines the available driver's license, ID, and permit for new Indiana residents. Please review each section carefully.

If you do not have one of the documents listed below, please visit RealID.IN.gov to review a full list of accepted documents.

#### **DRIVER'S LICENSE**

To obtain an Indiana Driver's License\*, please bring the following documentation to a BMV branch

#### One Proof of Identity

- Unexpired U.S. Passport or U.S. Passport Card
- Original or certified copy of a government issued birth certificate

#### Name Change (If Applicable)

 If your current name does not match the name on your identity document, additional name change documentation is required

#### One Proof of Lawful Status

- · Unexpired U.S. Passport or U.S. Passport Card
- Original or certified copy of a government issued birth certificate
- One Proof of Social Security (Your <u>FULL</u> Social Security Number must be printed on your documentation)
  - Social Security Card
  - W-2 Form

#### Two Proofs of Indiana Residency

- U.S. Postal Service change of address confirmation
- Utility company, credit card, doctor, or hospital bill issued within 60 days of application

If under 18 and held a driver's license less than 180 days then must apply for a LP, take knowledge exam. If under 18 and held DL for less than 1 year, they must take a knowledge and skills exam to get DL. If over 18 and DL is expired, then must take knowledge exam. If expired greater than 5 years, then skills and knowledge exam to get DL. If you cannot provide two documents proving your Indiana residency you may submit an Indiana Residency Affidavit. #### STATE ID

To obtain an Indiana State Identification Card (ID)\*, please bring the following documentation to a BMV branch

#### One Proof of Identity

- · Unexpired U.S. Passport or U.S. Passport Card
- · Original or certified copy of a government issued birth certificate

\*New Indiana residents are required to obtain a Real ID. Required documentation for a Real ID must be an original or certified copy and may vary based on each individual. For a complete list of required documents, visit RealID.IN.gov. If under 18, parent or guardian must sign for affiant, and proof of financial liability.

#### LEARNER'S PERMIT

To obtain an Indiana Learner's Permit\*, please bring the following documentation to a BMV branch:

#### One Proof of Identity

- Unexpired U.S. Passport or U.S. Passport Card
- Original or certified copy of a government issued birth certificate

#### Name Change (If Applicable)

 If your current name does not match the name on your identity document, additional name change documentation is required

#### One Proof of Lawful Status

#### One Proof of Social Security (Your <u>FULL</u> Social Security Number must be printed on your documentation)

#### Two Proofs of Indiana Residency

- U.S. Postal Service change of address confirmation

#### Certificate of Driver Education Enrollment

• If applying for a learner permit under the age of 16, the individual must show proof of enrollment in an IN BMV approved driver education program and dated no earlier than three weeks prior to the start of class

#### Pass Learner Permit knowledge exam

Pass a standard vision screening

### INDIANA RESIDENCY AFFIDAVIT

If you cannot provide two documents proving your Indiana residency you may submit an Indiana Residency Affidavit if you meet one of the following qualifications:

- You are incapacitated. An Indiana Residency
  Affidavit must be signed at a license branch by
  another person who is your legal guardian or
  caregiver, is at least 18 years of age, and with
  whom you reside.
- Homeless applicants without a residence address. An Indiana Residency Affidavit must be signed by a legal representative of the government entity or not-for-profit organization where you receive services and can receive mail.
- You are living with a relative or friend. An Indiana Residency Affidavit must be signed at a license branch by the relative or friend with whom you live.
- You reside in a motor vehicle, including but not limited to a mobile home or motor home.
   An Indiana Residency Affidavit must be signed at a license branch by another Indiana resident who attests that you may use his or her address of residence for record purposes.

#### **MOTORCYCLE ENDORSEMENT**

Individuals with an out-of-state motorcycle endorsement can obtain an Indiana motorcycle endorsement by meeting the below requirements:

# MOTOR DRIVEN CYCLE (MDC)

An MDC endorsement is applied to an ID card for the purpose of operating a motor driven cycle, when the applicant is at least 15 years of age and passes the MDC knowledge exam. Individuals holding a valid learner's permit or driver's license and are at least 15 years of age are able to operate an MDC without specific endorsement.

Upon completion of the course, graduation documents are electronically submitted to the BMV by course providers

#### FOR HIRE ENDORSEMENT

Individuals can obtain a For Hire Endorsement by meeting the below requirements:

an authorized Ride Safe Indiana provider or pass a skills exam.

- Hold a valid driver's license for at least one calendar year
- Are at least 18 years of age
- Pass a For Hire written knowledge exam

#### COMMERCIAL DRIVER'S LICENSES

Individuals who do not currently hold a Commercial Driver's License (CDL) can obtain one by meeting the below requirements:

- Bring all required documents to obtain their Indiana Driver's License and successfully complete all applicable CDL knowledge exam requirements
- Must submit valid Medical Examination Report (MER) and Medical Examiner's Certificate (MEC). Find FMCSA Certified Medical Examiners in your area here
- Age Requirements
  - At least 18 years of age
  - Make application for a Commercial Learner's Permit (CLP)
  - Drivers under 21 years of age may operate a commercial motor vehicle for purposes of intrastate commerce only and are not eligible to apply for the passenger, school bus, or hazardous materials endorsements

Individuals who have an out-of-state CDL and wish to obtain an Indiana CDL. These individuals are also required to pass all applicable CDL knowledge exams, must submit a valid MER or MEC, and must meet one of the below requirements:
