### NEXT STEPS

<b>Step 1: Data Accuracy</b>	Determine if your county’s racial and ethnic disparities data and analysis are accurate. If not, email Indiana Criminal Justice Institute’s (ICJI) Interim Racial and Ethnic Disparities (RED) Coordinator <sup>1</sup> for technical assistance.
<b>Step 2: Relative Rate Index Document Interpretation</b>	Determine if your county can interpret the racial and ethnic disparities data analysis. Are you able to identify the possible factors contributing to racial and ethnic disparities? If not, email ICJI’s Interim Racial and Ethnic Disparities (RED) Coordinator for assistance.
<b>Step 3: Implement System Improvement Efforts to Reduce Racial and Ethnic Disparities</b>	Determine if your county can implement system improvement efforts to address any identified racial and ethnic disparities issues. Identify evidence-based models that could be used and contact ICJI’s Interim Racial and Ethnic Disparities (RED) Coordinator for information on possible funding and other resources available.
