The Governor's Workforce Cabinet (GWC) requests a transfer of \$5,000,000 from GWC's Intermediary Capacity Building Grant appropriation fund (12373) to the Indiana Commission for Higher Education's (CHE) Intermediary Capacity Building Grant Fund (78210). Per an MOU between the two agencies, GWC is to transfer this funding to CHE for administration of the grant program in alignment with IC 21-18-19.

State Comptroller Elise Nieshalla moved to approve the transfer, State Treasurer Daniel Elliott seconded, and the transfer was unanimously approved.\

TRANSFER TO THE COMMISSION FOR HIGHER EDUCATION

The Indiana Department of Education (IDOE) requests a transfer of \$1,000,000 from IDOE's Donations Fund (47441) to the Commission for Higher Education's (CHE) Private Grants fund (44077). IDOE was awarded a private grant from the Walton Foundation that will be used to support project management contract costs at CHE related to implementing programs from House Enrolled Act 1002-2023.

State Treasurer Daniel Elliott moved to approve the transfer, State Comptroller Elise Nieshalla seconded, and the transfer was unanimously approved.
