Per IC 5-2-6-14, funding from the Victim & Witness Assistance Fund may be used to establish and maintain a victim notification system under IC 11-8-7 if the IDOC establishes the system.

State Treasurer Daniel Elliott moved to approve the transfer, Deputy Auditor seconded, and the transfer was unanimously approved.
