Indiana Trial Court Statistics

HOW TO USE STATISTICS BY COUNTY

- 1. Navigate to the Indiana Court Online Reports (ICOR) website https://publicaccess.courts.in.gov/icor/
- Select the applicable year from the drop down menu choices include 2010, 2011, 2012, 2013, and 2014.
- 3. Select the applicable county from the drop down menu
- 4. Select the applicable court from the drop down menu
- 5. Select the applicable view from the drop down menu choices include activities, trends, and data
 - a. Charts for Activities might include:
 - i. New Criminal Cases Filed
 - ii. New Civil Violations Cases Filed
 - iii. New Juvenile Cases Filed
 - iv. New Civil Cases Filed
 - v. Method of Disposition (All Cases)
 - b. Charts for Trends might include:
 - i. New Filings
 - ii. Disposed Cases
 - iii. Court Revenues
 - iv. Court Expenses
- 6. Choose the chart that displays the desired information
- 7. To produce a document, in your word processing software (commonly Microsoft Word) add a title based on the chart of your choosing
- 8. On the ICOR website, the icon will allow several options to download (PNG image, JPEG image, PDF document, SVG vector image)
- 9. Download an image. In most browsers, this appears as a popup.
- 10. Open the image and copy it
- 11. Paste into your word processing software (commonly Microsoft Word)
- 12. Add any additional text or charts before sharing the document.

CREATE A STYLIZED STATISTICAL REPORT

Many of you may want to create a document using a word processing program such as MicroSoft Word, which can then be utilized at county council or commission meetings and other public events. Below are helpful hints to create a stylized statistical report. We have provided a sample report.

- 1) Create a Cover Page
 - a) Select cover page style and insert title for the report
 - b) Grab a picture, if possible, from the court's website
 - c) Copy, paste, and format contact information as needed
 - d) If your county has a banner, include if you want
- 2) Format your document
 - a) Select one style including fonts to use throughout
 - b) Select complimentary color scheme
 - c) Be consistent with using headers provided in your style throughout document
- 3) Be creative
 - a) If available, use history of courthouse
 - b) Use Local photos
 - c) Judge Biographies
- 4) Make sure to include
 - a) Your county web page address
 - b) The county web page address for Trial Court Statistics: https://publicaccess.courts.in.gov/icor/report/index
- 5) Special Note on the Data page of the county web page
 - a) The public access web page does not have a button to download the data screen. Utilize the Snipping Tool that comes standard on most devices
