# **ICPR Extensions (Crystal Byrne)**

- D&E, ESC, and D&E Stabilization Programs to utilize ICPR Extension Form
- ICPR Extension Request Form
- Including these as part of regular communication and Annual Audits
- ICPR Extension Requests must be submitted—not a request for a new ICPR.
- Added D&E to extension requests same place as submitting ESC extensions.
- Will be getting some communications to ensure facilities are getting all ICPR's.
- Have identified some gaps, if run into any issues/questions please notify Residential Licensing.
- Put request in by day 20/30 day for D&E, for ESC submit requests by 15<sup>th</sup> day
- Integrated care team monitors dash boards on youth in these programs to ensure there is an accurate accounting of the children in the programs.
- Working hard to automate these systems.
- If want to send list of youth in your programs to Crystal you can but don't have too. But it is helpful.

 Were told for ESC at day 15, if not keeping youth in residential, to put in an urgent discharge request. Does that count against the facility. – Response - This assists with clear communication.

## Meeting

This is the centralized way to ensure there was clear communication with facility and placing agency on what day the child needs to be picked up from the facility. Facility can update the form, this will document the discharge notification to notify the plan is not to continue with the child in ESC after the 20 days. Will review to determine how to address this issue.
