- All Region 13 counties now have a Local Office Director after filling two vacant positions.
 - 12/30/2019 Trisha Skillman Lawrence County
 - 1/2020 Charlisa Davis Monroe County
- Monroe County Division Manager position is vacant & posted on the States job bank.
- Several Family Case Manager positions are available for Greene & Monroe Counties
- Region 13 added several Foster Care positions
- Region 13 Legal Division is fully staffed
- Job fair at IU Jan 28th & 29th to potentially recruit May graduates
- Child Abuse Awareness Month is in April
 - Community Partners will be in contact with local offices to coordinate events
- Parent Café Outreach is now occurring in all 5 Counties
- Face to Face Contacts in all Counties was almost 100%, meeting our personal Regional goal
- Residential Placement Committee meetings are now occurring at the County level
 - Monroe has 18 youth in Residential placement as of 1/23/2020
 - As an agency the overall goal is to have "0" youth placed in Residential care. This is not always going to be realistic. Therefore, Region 13 strives to have 10 or less youth placed in Residential placements.
