 - ii. Asked permission for \$75k in prevention funding to assist with concrete needs for the proposed FRC in Tippecanoe County.
 - 1. This would be for upgrades to the facility (including laundry) as well as supplies.
 - 2. Motion was raised and seconded and agreed to by members.
 - iii. Samuel Brooks (NYAP) asked about the potential for this to support foster, relative, kinship placements.
- c. Community Partners had additional prevention funding and will be putting out an RFP to the Region.

- a. Iwona provided information about opportunities for DCS partners to learn more about Family Preservation Services (FPS) and DCS Practice Model.
 - i. Judge Graham asked if Probation Officers would be able to attend the DCS staff FPS forums.
