## Public Hearing for Region 1 Biennial Plan

DCS Lake County, Region 1 Regional Manager, Ellis Dumas, read public testimony guidance sheet.

We will be utilizing this information as we begin the important process of preparing our Biennial Regional Services Strategic Plan. The specific target of this discussion is the individual needs of children who:

- 1. Have been either:
  - a. Adjudicated as, or alleged to be, children in need of services or delinquent children; or
  - b. Identified by the department, based on information received from:
    - i. A school;
    - ii. A social service agency;
    - iii. A court:
    - iv. A probation department;
    - v. The child's parent or guardian; or
    - vi. An interested person in the community having knowledge of the child's environment and family circumstances; and after an informal investigation, as substantially at risk of becoming children in need of services or delinquent children.

Please be sure you have signed up if you intend to provide public testimony. If you have written testimony, please be sure to turn that in before the close of the meeting. No additional written testimony will be accepted following the meeting. Your comments will be limited to 3 minutes. When you step up to the microphone, please state your name for the record and also indicate the name of the agency or group you are representing if that is applicable. Comments must relate to local service needs and systemic changes. Comments should not be used for sales and marketing of specific programs. This is an opportunity for the public to provide input to the Regional Service Council. The Regional Service Council will not be answering questions posed during the public testimony. Any questions will be answered in writing at a later date and posted on the DCS website. I will let those of you speaking know when you have reached the 2 minute mark

and also the 2 ½ minute mark so you can wrap up your comments. Thank you for taking the time to provide this important information to us.
