After consulting with the City of Lafayette Building Commissioner and Assistant Chief of Fire Prevention, we made the determination to submit for a variance to the construction of a fire apparatus access roads in accordance with Section 503 shall be provided within 150 feet (45 720mm) of all portions of the exterior walls of buildings used for high-piled storage.

The new high-piled combustible storage accessory building proposed for the Menards Lafayette Indiana store located at 2850 South Creasy Lane is required by Chapter 5 of the 2014 Indiana Fire Code to be provided with fire department access.

This current site provides for fire department access to the front of the proposed building. Additional access to the rear of the building would require an access road be installed. The Lafayette Fire Department has determined the current site meets its needs for fire department of the proposed accessory building at this time.

This letter is to support a variance from the 2014 Indiana Fire Code requiring the fire department access road be provided at this time <u>with the condition</u> that fire department access be provided at the time of development of the site directly to the north of this proposed accessory building.
