b. New

- i. **22-12-79(a)(b) Third and Grant – Building A, Bloomington** – (a) Melissa Tupper presented. Variance concerning smoke dampers and duct work. Code requires a smoke damper at each point that ductwork penetrates and serves the corridor. Limited space within floor to ceiling assembly makes providing smoke dampers at every penetration difficult. Asking to use a combination smoke/fire damper that would be provided in the floor, and a ceiling damper, as well as secondary dampers triggered by the first one. Bobby Larue presented as well, noting that he wishes that corridor smoke detection should initiate the building alarm and close all dampers required to be closed. (b) Concerns balconies and amended language for Indiana code requiring sprinklered balconies to be rated. Bobby Larue addressed the Commission again, noting that he believes that the rating should stand. Building Commissioner Burgess read opinion 38 into the record, as it was relevant to the proceedings. Technical discussion of fire ratings and possible alternative protections proceeded, as well as what counts as a projection and in what circumstances. Vice-Chair Pannicke notes that we have issued variances based on model code language when an Indiana Amendment creates a conflict. Commissioner Cook indicated that discussion of why the Amendment was made is outside the scope of determining whether the individual variance request is reasonable. Commissioner Heinsman questioned whether fire-treating the wood would create additional safety if the question is fire bypassing the wood. More technical discussion ensued concerning types of

balconies, siding, what stage of construction the buildings are currently in, etc. A suggestion was made that penetrations be sealed from the inside to avoid deterioration of the sealant. Ed Rensink suggested multiple layers of solid blocking in between the beams where they cantilever out.

Conditions: (a) Corridor smoke detection will trigger building alarm per Indiana adopted NFPA 72. (b) Approved with the addition of fire-stopping at all cantilever beam penetrations through the exterior wall from the inside. Sprinkler protection at all balconies.

Asking to use Chapter 34 for the change of use. Cost estimate for sprinkler system upgrade approximately 840k. Commissioner Heinsman would like to see legible structural plans before moving forward. Commissioners Pannicke and Popich would like to see cost estimates for door flips, minimum exiting.
