ORDINANCE NO. 7 -2015

AN ORDINANCE ADOPTING FIRE SAFETY & BUILDING RULES
FOR THE TOWN OF ROACHDALE

WHEREAS, the Town Council of the Town of Roachdale, Indiana, has determined that for reasons of public safety, under the provisions of Indiana Code 22-13-2, the Town should adopt an ordinance regulating fire safety and building and structures.

NOW THEREFORE BE IT ESTABLISHED AND ORDAINED by the Town Council of the Town of Roachdale, Indiana ("Town"), that:

- A. Building Rules Adopted. 1. Pursuant to I.C. 22-13-2-3(b) the Town hereby adopts the fire safety and building rules and codes adopted by the Indiana Fire Prevention & Building Safety Commission ("Commission") as set forth in the Indiana Administrative Code, including but not limited to rules made under I.C. 22-13-4-5 governing the conversion of buildings from one class of occupancy to another and the requirement for Town review of plans and design releases under I.C. 22-15-3.3.
2. The Roachdale Town Superintendent shall be and hereby is the municipal officer designated and authorized to enforce these rules and codes hereby adopted.

B. State Review. As required by I.C. 22-13-2-5, within thirty (30) days of passage of this Ordinance, the Clerk-Treasurer shall submit a copy of this Ordinance to the Commission for its review.

C. Miscellaneous.

1. This Ordinance shall remain in full force and effect from and after its passage and statutory approval by the Commission.

2. This Ordinance replaces and repeals any previous ordinances or parts of ordinances that are in conflict with this Ordinance.

3. In the event that any provision of this Ordinance is held to be invalid by a court of competent jurisdiction, all other provisions of this Ordinance not otherwise invalidated shall remain in full force and effect.
