FINAL ORDER OF DISMISSAL

On August 24, 2021, Respondent filed a Joint Motion to Dismiss in the above-captioned matter based on the Parties' informal resolution of the issues on appeal and on Petitioner's request that this matter be dismissed.

The ultimate authority in this matter is the Fire Prevention and Building Safety Commission ("Commission"). The Commission has authorized the ALJ assigned by the Office of Administrative Law Proceedings to serve as the ultimate authority and to issue final orders of dismissal when the Petitioner withdraws the appeal or the parties file a joint or agreed request to dismiss the appeal. The undersigned ALJ therefore issues this final order dismissing the above captioned matter with prejudice and vacating the initial pre-hearing conference scheduled for 8/26/2021.

A person who wishes to seek judicial review of this final determination must file a petition for review in an appropriate court within thirty (30) days of this Order and must otherwise comply with the provisions of Ind. Code § 4-21.5-5.

Our office received the attached petition for administrative review concerning the State Building Commissioner's written interpretation CEB-2021-28 . . that you had requested on July 12th. You are not currently a party to this matter, however, Mr. Sorah of Wayne County has informed us that the actual violation, and dispute in question concerning this written interpretation, was not to Table R404.1.1(1) footnote a, but was actually concerning Section R404.1.1 footnote 1. I wanted to notify you of this development to make sure that this interpretation is not misused in any way or understood to state that Section R404.1.1 footnote 1 can not be applied in this current matter that led to this dispute or in any matter that may later arise and to be clear that this interpretation solely applies to the language of Table R404.1.1(1) footnote a.

I have also copied Mr. Boyle and the Office of Administrative Law Proceedings on this matter to notify them that the parties to this matter have discussed the request for review and have agreed that administrative review of this matter is unnecessary. In hopes of resolving this matter before an administrative law judge is assigned, the Department would request that this matter be dismissed by joint agreement of the parties and upon Mr. Sorah's confirmation that he indeed desires to dismiss this action.
