## Reports

Dr. Yazel didn't have anything specific but encouraged anyone to reach out.

Brittany Fortinberry still working on getting the grant money distributed.

Director Kinney stated that the biggest legislative item for MIH will be asking for grant money again in 2023.

## Program Overview

South Bend Fire Department – Andy Meyer gave an overview of their program.

South Bend started looking into a program in 2012. They started their program in June 2018. Participated in the Homebound Hoosiers program to give COVID vaccines. Meyer talked about the education that their MIH paramedics are going through. Meyer talked about all the services they help provide.

## Old Business

Fortinberry gave an updated on suggested education requirements for the MIH paramedics. Fortinberry suggests a total of 40 hours broke down to be 25 hours of didactic lessons, 5 hours of lab based psychomotor skills, and 10 hours of clinical experience. Suggested components would be advanced patient interviewing, social resource availability, social determinants of health, cultural competency, public health and wellness, role within the community, and personal safety and wellness. Discussion followed.

Chairman Kinney discussed the vacant board positions and asked that if anyone had any suggestions for the opened EMS Medical Director or MIH-CP patient positions to let him know.

New Business

Brittany Fortinberry reviewed the application and the information that is being collected. Director Kinney reviewed the reason for the application process. Fortinberry gave an overview of the pending applications: Rush Memorial Hospital.
