NON-FINAL ORDER OF DISMISSAL

Respondent, the Indiana Department of Homeland Security, performed an inspection of Petitioner, Good Shepherd Christian Academy, on February 28, 2019, and issued an inspection report citing Petitioner for one building and fire code violation. On March 8, 2019, Petitioner filed a petition for review of the violation in that inspection report. Following initiation of this appeal, Petitioner obtained a variance from the Fire Prevention and Building Safety Commission at the May 9, 2019, meeting, which rendered this petition for review moot. As a result, Petitioner has filed a motion to dismiss the petition for administrative review, and Respondent has no objection.

Accordingly, the Administrative Law Judge now enters this Non-Final Order of Dismissal. The ultimate authority in this matter is the Fire Prevention and Building Safety Commission. Indiana Code § 4-21.5-3-29(d) requires any party seeking to preserve an objection to this order for judicial review to file a written objection that:

- 1. identifies the basis of the objection with reasonable particularity; and
- 2. is filed with the Commission within fifteen days (or any longer period set by statute) after this order is served.

In the absence of an objection from a party or notice from the Commission of its intent to review any issue related to this order, the Commission shall affirm this order in accordance with Indiana Code § 4-21.5-3-29(c). **This order will be considered by the Commission on Tuesday, June 4, 2019, at 9:00 (EDT), in Conference Center Room B, Indiana Government Center South, 302 West Washington Street, Indianapolis, IN 46204.**
