## PRELIMINARY REVIEW OF LOCAL ORDINANCES

**Note:**

This report has been prepared to provide comprehensive awareness and transparency of the ordinances containing building and/or fire safety laws that have been submitted to the Indiana Fire Prevention and Building Safety Commission’s (Commission) staff, requesting preliminary review, as afforded by Indiana Code § 22-13-2-5.5(1). The Commission and its staff encourage local political subdivisions with authority to adopt ordinances to submit their unadopted, draft ordinances containing building and/or fire safety laws to the Commission’s staff for preliminary review prior to adoption by the adopting body. Indiana Code § 22-13-2-5.5(1) requires the Commission’s staff to furnish the results of a review to the requester within a **reasonable time**.

After receipt, the Commission’s staff will place draft ordinances submitted for preliminary review on the Commission’s meeting agenda and provide a copy of the draft ordinances with the Commission’s meeting materials for the Commission’s and interested stakeholders’ awareness, so that the members of the Commission and interested stakeholders may provide comments and concerns to the Commission’s staff. Indiana Code § 22-13-2-5 and Indiana Code § 22-13-2-5.5 do not require the Commission to take any formal actions on unadopted, draft ordinances submitted for preliminary review. Adopted ordinances that contain building and/or fire safety laws will still be placed on the Commission’s meeting agendas and processed in accordance with the requirements of Indiana Code § 22-13-2-5.5.

This report will be updated on a regular basis and will be provided to the Commission at its regularly scheduled meetings.
