4. Evidence Supporting Claim of Prejudice (please attach copies of all supporting documentation)

Recently discovered unforeseen building conditions and overall project schedule necessitate this late variance filing request. The unforeseen conditions have caused a significant change in the strategy to provide fire-rated separations between floor levels within the vertical cavity created by the new overcladding applied to the exterior wall of the building. This new strategy requires a variance request from the Comission's rules due to the necessity of providing an alternative method of protection for the issue described that does not meet the prescriptive requirements that apply to this condition.

Specifically, this M74 façade replacement project has been working in excess of 60 hours per week, with some 2<sup>nd</sup> shift operations since late April 2018 and submitting this variance for the April 2, 2019 hearing would unnecessarily temporarily displace approximately 250 workers by at least one month and cost the project well in excess of \$200,000. We respectfully request the State of Indiana allow us to present our variance at the March 5, 2019 meeting.
