**FINDINGS AND FINAL DETERMINATION ON PROPOSED QUESTION
RESUBMITTED FEBRUARY 1, 2016**

1. On January 15, 2016, the Department of Local Government Finance (“Department”) disapproved referendum question language proposed by the Metropolitan School District of Southwest Allen County (“Corporation”), which proposes to place an operating referendum on the ballot for the purpose of establishing a referendum tax levy with a tax rate not to exceed fifteen cents (\$0.1500) per one hundred dollars (\$100) of assessed value.
2. On January 21, 2016, the Corporation submitted revised proposed language, which the Department again disapproved. On February 1, 2016, the Corporation submitted further-revised proposed language.
3. Under Indiana law, voters in the area served by the Corporation will vote in a referendum to approve or deny the Corporation’s proposed tax rate.
4. Indiana law governs the format and wording of the ballot question for the referendum.
5. Under Indiana law, the “question to be submitted to the voters in the referendum **must read as follows**”:

“For the __ (insert number) calendar year or years immediately following the holding of the referendum, shall the school corporation impose a property tax rate that does not exceed _____ (insert amount) cents (\$0. __) (insert amount) on each one hundred dollars (\$100) of assessed valuation and that is in addition to all other property taxes imposed by the school corporation for the purpose of funding _____ (insert short description of purposes)?”

Indiana Code 20-46-1-10 (emphasis added).

6. The law requires the Department of Local Government Finance (“Department”) to review the language for compliance with IC 20-46-1-10. The Department may either approve or reject the language.

7. The Corporation has requested that the Department review this proposed question:

“For the seven (7) calendar years immediately following the holding of the referendum, shall the M.S.D. of Southwest Allen County impose a property tax rate that does not exceed fifteen cents (\$0.1500) on each one hundred dollars (\$100) of assessed valuation and that is in addition to all other property taxes imposed by school corporation for the purpose of funding a continuation of the current class sizes, student services and school safety?”

Compliance of Language


8. The Department must review the proposed language for compliance with IC 20-46-1-10. The Department may either approve or reject the language. The Department concludes that the language is in compliance with IC 20-46-1-10. The Department notes that the Corporation’s proposed question is missing a “the” in the phrase “imposed by school corporation.” The Department does not object to the language as proposed, but the Corporation is welcome to submit revised language if it chooses to do so.

Final Determination

WHEREFORE, based on the above findings and applicable law, the Department finds that the proposed language is in compliance with IC 20-46-1-10 and approves the language as proposed.
