Welcome to the Indiana DNR's online game check-in system, CheckIN Game. This guide will run you step-by step through the process of checking in your wild game via our online system. Check in your game either by logging in to your On-Line Services account or by simply entering your customer ID and date of birth. Viewing the history of your previous game check in records is only available through an On-Line Services account at:

Step 1: Go to: www.checkingame.dnr.in.gov and click on the option to "CHECK IN YOUR GAME ONLINE" If you know your customer ID, just enter it with your date of birth and submit. Then skip to Step 3.
