# Expanding the Purpose of the Stewardship Committee, Jack Seifert

Handout: Indiana Forest Stewardship Coordinating Committee: Mission Statement & Operating Procedures – 2010 DRAFT

The Division of Forestry would like to shift the mandate of the Forest Stewardship Coordinating Committee to include the implementation of 2010 Statewide Forest Strategy. Draft Mission Statement and Operating Procedure was presented to committee for review. The draft also increases the meeting schedule to 3 times per year (September, January, and May).

Changes made to the draft by the committee:

Mission Statement – Second Paragraph- Second Sentence

Draft Statement: "The Indiana Forest Stewardship Coordinating Committee has no authority to formulate state forest policy, but functions to promote communication and understanding of current forest management issues."

Revision: "The Indiana Forest Stewardship Coordinating Committee informs state forest policy functioning to promote communication and understanding of current forest management issues."

With change, committee accepted the revision of the Mission Statement & Operating Procedures.

# Forest Legacy Program, Brenda Huter

**Discover Woods** 

The Forest Legacy Program is a US Forest Service Program that provides grants to states to purchase in fee or purchase conservation easements on important working forests within state designated Forest Legacy Areas. Indiana may submit 3 projects up to \$10,000,000 each year to the US Forest Service. Projects from across the nation or ranked. The ranked projects are then submitted for federal funding.

Indiana currently has about 7,000 Forest Legacy acres completed. In the past year, the Hills of Gold II easement has been purchased but final federal paperwork has not been completed so the project is not yet closed. This leaves one active project: Luke's Run Project in Owen County.

Discover Woods Project was submitted for 2011 funding. The project made the President's List with funding for the Happy Hollow Tract, but the federal budget has not been released.

Projects for 2012 funding are due end of October. The Division of Forestry's recommendation is to resubmit the Discover Woods Project. No new applications have been received in the past year. Committee approved.

# Strategic Forestland Conservation Program, Chris Gonso

The first action step under Statewide Strategy #1 (Conserve, manage and protect existing forests, especially large forest patches) is the development of the Strategic Forestland Conservation Program to work on planning in Target Forest Patches: Ravinia, South-Central Indiana Patch (Shawnee Hills, Brown County Hills, and Knobstone) Patoka, Bluegrass, Whitewater, Sugar Creek, Little Pigeon, Raccoon, Minnehaha. Data and maps were also provided relating to location and trends affecting existing large forest patches and showed current availability of statewide parcel level information to help make conservation and stewardship efforts more efficient and effective.

### Thousand Cankers Disease, Phil Marshall

US range of *Juglans sp.* is mainly in eastern half of the country. Thousand cankers disease is moving from western US. It has identified in Tennessee in street trees. It has not been currently identified in Indiana. 8 states including Indiana have enacted quarantines on black walnut. Several other states are working on quarantines. *Pityophthorus juglandis* is the beetle that is carrying the *Geosmithis morbida* fungus spores that causes the cankers. As the beetle borers into the tree, it inoculates the tree with the fungus. Early symptoms (late June/August) appear anywhere in the crown, a portion of the crown may look thin, die back of branches. Affected trees die in approximately 3 years. In the next year, the Division of Entomology will begin doing some survey work to look for thousand cankers disease.

Indiana Emergency Rule: Applies to any walnut originating from or transiting through a regulated area. There are exemptions for nuts, processed lumber that is 100% bark free, kiln dried with square edges, finished wood products. To get a compliance agreement to move walnut through Indiana the material must be inspected at the point of origin and must deliver a phytosanitary certificate to the state entomologist at least 24 hours before the material enters Indiana. A state inspector will check the product when it arrives.

# Forestland Property Tax Assessment Impacts, Phil Wagner

PowerPoint Presentation: Forest Assessment

Division of Forestry is working with Department of Local Government Finance to get consistent assessment of forestland statewide. The law says that land assessment is to be based on use. If a forest is being used for an agricultural product (timber, maple syrup) then the land should be assessed at the agricultural rate with an 80% deduction. If the forest is being managed for other things not including an agricultural product then the land is to be assessed at excess

residential. Counties are not consistently assessing forest. Evidence of using forest for agricultural products: management plan, financial records demonstrating management records.

# **Roundtable Reports**

This agenda item was moved forward for this meeting to facilitate development of Action Step work groups/subcommittees as members were asked to share organizational capacity information - staff numbers and budget - as well as accomplishments and goals.

<u>IUFC:</u> 2010 accomplishments include the following: Sample Urban Statewide Inventory Tools brochure mailed to legislators and town government; working on a media campaign to raise the awareness about the value of community trees. In 2011, IUFC will work to increase contact with legislators about the importance of increasing tree canopy cover to the recommended in 25% and to increase IUFC's funding stream with the goal of providing grant funds for tree planting projects within cities and towns not currently eligible for funding through the CUF program.

<u>IFWOA:</u> Professional Foresters Directory is now online. The new professional directory is due in 2011. Timber Harvest Meetings 4 meetings across the state; November 5 & 6, 2010 Landowner conference. Ties to the Land - Successional Planning available to other organizations.

<u>DNR Nature Preserves</u>: The division is still intact despite budget challenges. Nature Preserves has a project on Hoosier National Forest identifying RTE species. The runs the Natural Heritage Database and works with the Division of Forestry in planning initiatives by sharing this data. In the future Nature Preserves will be partnering with Division of Fish & Wildlife to do habitat restoration using Pittman Robinson dollars.

<u>Hoosier National Forest</u>: The forest is celebrating its 75<sup>th</sup> anniversary. The Hoosier NF manages 202,000 acres in 9 counties. The Forest Plan 2006 guides the multiple use management on the property. Ken Day retired in June. New forest supervisor should be in place by Jan. Two forest closure orders have been issued: caves have been closed due to white nose syndrome in bats; firewood closure to prevent EAB spread. Past year funding has been good due to stimulus money. 2011 budget still in the air, but reductions are expected. The forest has 60 employees, and \$6 million budget. In 2011, American chestnut plantations will be planted on the forest. Landscape scale conservation is being pushed to achieve conservation goals.

<u>Backcountry Horsemen</u>: Backcountry Horsemen is a non profit group that works to maintain & build trails on federal & state land. The group has 4 master educators in leave no trace. There are approximately 80 members in organization.

<u>IHLA</u>: IHLA has joined with IFIC (Indiana Forest Industry Council). The purpose of IHLA is to promote forest products and provide loggers professional training. IHLA is publishing a list of loggers based on the amount of training they have had (gold, silver, bronze). More mills are

becoming green certified. IHLA has completed the branding website "Premium Indiana Forest Products." On the website users can find forest products by using a map. IHLA was involved with the Habitat for Humanity house and the Boy Scout Bridge at the 2010 State Fair. Department of Agriculture is promoting forest exports during overseas markets trade missions.

<u>IFA:</u> Organization has been working on ending logging ended in backcountry of Morgan Monroe State Forest. IFA would life to see an increase of old growth forests in Indiana. IFA is also working on sustainable logging on private lands. In the upcoming year goals include promoting the forest resources to help the public understand the importance of their forests and continuing their backcountry efforts.

<u>Ecologic:</u> Ecologic is working to get Southern Indiana Cooperative Weed Management Organization (SICWMO) established. They are currently working to hire a director for the Weed Management Organization. SICWMO purpose will be to get landowners information on invasive species and find resources to get control done.

<u>Purdue FNR</u>: Purdue FNR seeks to provide the science to achieve goals for forest & wildlands. Landowner extension programs continue with various partners. HEE (Hardwood Ecosystem Experiment) update: Morgan Monroe State Forest clearcut is complete with interpretive sign; the HEE baseline information is to be published by the USFS Experimental Station; conducting various management strategies to monitoring impact. Purdue is starting a series of online educational programs using Adobe Connect.

<u>HEC</u>: HEC's focus on improving clean energy policies, sustainable agriculture, and alternative transportation. In 2010: Energy- pushing for net metering policies to provide credit for excess energy produced by on a property. Clean air act enforcement settlement with Duke reducing air pollution, \$5 million mitigation to go to the US Forest Service; Transport- Patoka acquisition using \$11 million from Peabody Coal. 2011: Energy - Property Assessed Clean Energy funding for retrofitting; Agriculture - better standards for CAFOs, Transportation - legislative effort to expand funding for public transport in urban areas bolster bus and install commuter rail, continue effort to change I-69 route by increasing awareness.

<u>IN Association of SWCD</u>: Organizations comprised of representatives from 92 local SWCD. It publishes a weekly newsletter to SWCDs. The association is working to get bill passed for natural resource funding. It also has representation on the national levels.

<u>FSA:</u> CREP (Conservation Reserve Enhancement Program) expansion- In 2005 there where 3 watersheds slated to enroll 7,000 acres, touching 29 counties. In 2010, the program was expanded to 11 watersheds slated to enroll 26,250 acres and touching 65 counties. Practices include hardwood tree plantings, bottomland timber, and riparian buffers. Currently there are 800 active CREP contracts (5,700 acres). CRP 39, the first general signup since 2006, just closed. For Indiana, land was approved in 78 counties. The goal is to maintain program enrollment.

<u>Purdue University Hardwood Tree Improvement Regeneration Center</u>: The center is working on genetic improvement of 6 tree species. Breeding program for black walnut for resistance 1,000 canters disease is starting. Will study to see if there in a difference resistance between black walnuts in a native forest & urban setting. Other projects include restoration of butternut and American chestnut.

<u>Division of Fish & Wildlife</u>: Working with partners on wildlife habitat issues, invasive species monitoring, and the governor's Wabash & Muscatatuck initiatives.

<u>IWF:</u> The director's position open. John Goss left to working on Asian carp. IWF is a broad base conservation group focusing on backyard habitat, education/outreach, clean water, clean air, rough grouse decline early successional habitat. Travis Stoelting, biologist from Purdue University, has been hired to work on forest issues: habitat improvement projects, development on documents on forest management educational.

<u>IACF</u>: Organization is open to consultant foresters. The groups focus is on professional development & education. IACF develops the pricing report in Woodland Steward. Current area of interest include forest certification- cost & implementation, invasive species control (working with cooperative weed management areas), and economics of forest management.

<u>ISAF</u>: ISAF is part of the national organization for professional foresters. The focus at national & state level is on forest policy, education, promotion the profession (concern about the decline in forest enrollment in college). ISAF supports the Woodland Steward,

<u>TNC</u>: TNC has added 3,000 of protected land some of which is going to Hoosier National Forest & DNR Division of Forestry. Ellen Jacquart has been instrumental in getting the Invasives Council going. Dan Shaver is working to reenergize the Forest Bank Program. TNC is partnering on the Wasbash & Muscatatuck project areas.

<u>Sycamore Trails RC&D</u>: RC&D covers west- central Indiana. The organization is focusing on eradication of bush honeysuckle & multiflora rose.

<u>Monroe County Landowner</u>: Working to keep urban & rural areas separate in planning. In the rural areas, the land cannot subdivide land in saturated area. Limitations on other rural areas must be approved by planning commission. This effects landowner's ability to landowner to move their land may depreciate rural land values.

<u>Sierra Club</u>: The organization has not been much involved in forest issues. Recent focus has been on removing phosphate from lawn fertilizer, working on recreation access to the Lost River. The club is supporting efforts to stop logging in back country area of State Forests. The organization would like to see more old growth forest in public ownership. Group members are interested in recreation and hiking.

<u>USDA:</u> USDA has contribution agreements with the Division o Forestry. Professional foresters are used for invasive species, TSI, riparian buffers, and planting projects. Division of Forestry had separated EQIP funding (CCPI). USDA is working with Purdue to provide Forestry training to district conservationists. Sycamore Trails had invasive species workshops around the state. USDA would like to prioritize invasive species control funding. Web Soil Survey is adding black walnut index.

<u>Indiana Walnut Council:</u> Group has 130 members. Its purpose is to encourage landowners to plant trees and forest management. There are 2 meetings a year.
