## Introduction

The Indiana Department of Revenue has the sole authority to prescribe and furnish forms and schedules used in the administration and collection of state income taxes. The list of forms in this bulletin are current as of the 2022 tax filing year. These forms are available to the taxpayer free of charge upon request.
