<b>Subject Matter</b>	Amends 405 IAC 1-12-21 to increase the rate paid to any Medicaid-enrolled Large Private Intermediate Care Facilities for Individuals with Intellectual Disabilities that are licensed as a Comprehensive Rehabilitative Management Needs Facility to seven hundred three dollars and ten cents (\$703.10) per resident day. The proposed change also creates consistency between the language used in the title and the body of the rule.
