

Profile Report Field Definitions

The fields on the Profile Report are defined below.

Reporting Period	The 12-month period during which reported children were enrolled or services took place
Population	The population of the selected geographical area, based on the most recent figures published by the U.S. Census
Population Growth Percentage	The population growth rate of the selected geographical area, based on the most recent figures published by the U.S. Census. Note: This field does not appear on the Cluster Profile Report.
One-day Count w/IFSP - 0- to 1-year-olds	The unduplicated number of children under age 1 with an active IFSP on the first day of the last month of the reporting period
One-day Count w/IFSP - All Children	The unduplicated number of children with an active IFSP on the first day of the last month of the reporting period
Annual Count of Children w/IFSP	The unduplicated number of children with an active IFSP at any time during the reporting period
Annual Count of Children Served (regardless of IFSP)	The unduplicated number of children who received a service during the reporting period, regardless of IFSP status. This count includes assessments and evaluations as well as treatment services.
Average Age at Referral (months)	For children referred during the reporting period, the age in months as of the referral date, divided by the total number of children referred during the period
New IFSP [MM/DD/YYYY - MM/DD/YYYY]	The unduplicated number of children whose first IFSPs were started during the last three months of the reporting period
Children with Referral to IFSP 45+ Days [MM/DD/YYYY - MM/DD/YYYY]	The unduplicated number of children whose first IFSPs were started longer than 45 days after referral during the last three months of the reporting period
Children Moving to Preschool Special Education	The unduplicated number of children who exited the First Steps program to Preschool Education during the reporting period, plus the percentage this exit category represents out of all children exiting during the reporting period

Children under 3, Services No Longer Needed	The unduplicated number of children who were determined no longer to be in need of First Steps services during the reporting period, plus the percentage this exit category represents out of all children exiting during the reporting period
Eligible Children who Declined Services	The unduplicated number of children who decline services during the reporting period, plus the percentage this exit category represents out of all children exiting during the reporting period
Children w/IFSP Served Primarily in the Natural Environment	<p>The unduplicated number of children who received services at locations where a normally developing child would receive services, along with a percentage of all children served. Children are included in this count if:</p> <ul style="list-style-type: none"> • At least half their services during the reporting period took place at one or more locations considered as natural environment; • Their only services during the reporting period were assessment, evaluation or family planning meetings; or • They received no services during the reporting period
Total Amount Paid on Behalf of Children Served	The total amount paid for services taking place during the reporting period
Average Paid on Behalf of Each Child Served	The total amount paid for services taking place during the reporting period, divided by the Annual Count of Children Served (regardless of IFSP)
Number of Children Annualized Claims Paid Top 5%	The unduplicated number of children making up the top 5% of the amount of claims paid. For example, if a county had \$100,000 in claims paid for a year, this count would show how many children's services make up the top \$5,000.
Race Information	The number and percentage of all children receiving services, broken out by race. A child is counted in only one race.
Children Receiving Each Service Type	The number and percentage of all children receiving services, broken out by service type. A child is counted in each type of service received during the report period.
