Re: Approval of the *Indiana Design and Installation Manual, for**Presby Advanced Enviro-Septic® Wastewater Treatment System,

August, 2019

The Indiana Design and Installation Manual for the Presby Advanced Enviro-Septic® Wastewater Treatment System, August, 2019, is hereby approved as the current design and installation manual for the system listed above. This approval of the design and installation manual is for use in commercial on-site sewage systems and individual residential on-site sewage systems. Approval is effective October 1, 2019.

- I. Presby Environmental, Inc. is required to:
 - a) Certify manufacturers, distributors, designers, installers and service providers;
 - b) Submit to the department a list of all certified installers, distributors, service providers and manufacturers for the State of Indiana annually; and notify the department immediately of the removal of any certified installer, distributor, service providers or manufacturer;
 - c) Submit for review and approval of the department any proposed changes to any system component or the *Indiana Design and Installation Manual for the Presby Advanced Enviro-Septic Wastewater Treatment System, August, 2019* prior to implementation of the changes;
 - d) Notify the department of any scheduled training event at least 10 working days prior to the event;
 - e) Provide on-going consultation to health department staffs, designers, installers, and service providers;
 - f) Submit to the department on an annual basis the installation of any on-site sewage system installed that includes a Presby Advanced Enviro-Septic® Wastewater Treatment System using a data format provided by the department.
- II. The Presby Advanced Enviro-Septic® Wastewater Treatment System is subject to:



- a) The applicable provisions of ISDH Rule 410 IAC 6-8.3, or ISDH Rule 410 IAC 6-10.1, whichever is applicable;
- b) Receiving and dispersing only domestic and/or residential strength wastewater;
- c) The Indiana Design and Installation Manual for the Presby Advanced Enviro-Septic[®] Wastewater Treatment Systems, August, 2019.

III. The Presby Advanced Enviro-Septic® Wastewater Treatment System manufacturer, designer, distributor, installer, and service provider is subject to:

- a) Presby Environmental, Inc., certification;
- b) Maintaining a status of good standing with Presby Environmental, Inc.

This approval may be revoked or modified by the department for non-compliance, or if it is documented that it would not be in the best interests of public health for approval to continue.

If you wish to request administrative review of this *Approval* pursuant to Indiana Code 4-21.5-3-5, you must file a petition for review within fifteen (15) days after this *Approval* is received.

The petition for review must be in writing and must include facts demonstrating that:

- The petitioner is a person to whom the Approval is specifically directed;
- The petitioner is aggrieved or adversely affected by the Approval; or
- The petitioner is entitled to review under any law.

If the petition for review is not filed timely, this Approval becomes FINAL. Any petition for review and petition for stay of effectiveness must be submitted in writing to:
