
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Jordan Ross, driver of No. 1 FLYINGSIX, fined \$300.00 for whipping with more than minimal wrist and elbow action past the half. The penalty was increased due to Mr. Ross' previous whipping fines and the number of times he hit the horse.


Race 3 - Inquiry posted looking into the start of the race and whether No. 9 HEAD GAMES made the fair start pole. Video showed that No. 9 HEAD GAMES was not inside the fair start pole prior to the rest of the field being released. No. 9 HEAD GAMES declared a non-starter for wagering purposes. Refunds issued on all wagers involving the horse.

Race 5 - Inquiry posted on unofficial third place finisher No. 2 ALL STAR SWAN (LeWayne Miller) for possible violation of the breaking rule past the quarter. Video confirmed that Mr. Miller complied with all aspects of the breaking rule and there was no reason for disqualification. Horse placed as finished.

Race 6 - No. 3 CLOSED DEAL (Trace Tetrack) originally finished sixth placed tenth for an extended break in the stretch. Jamie Macomber, trainer of No. 1 YOUHADMEATHALO, fined \$100.00 for failing to have the horse properly equipped and missing the post parade.
